BOARD OF COMMISSIONERS

Approve Amendment #1 to the Intergovernmental Agreement with Mid-Willamette Valley Council of Governments to add \$45,000 for Marion County's share to fund a program coordinator position for the Mid-Willamette Homeless Initiative through June 30, 2020.

COMMUNITY SERVICES

Approve an order appointing Mike Adams and Ken Outfleet, and re-appointing Shannon Gubbels, to the Marion County Fair Board with terms ending December 31, 2021.

MOTION: Commissioner Brentano moved for approval of the consent agenda. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.

COMMUNITY SERVICES

1. Consider approval of an order establishing a three-year term for Marion County Fair Board Key Volunteers and establish term ending dates for Bry Taylor Campos with an ending date of December of 2019 and Amy Goulter-Allen with an ending date of December of 2020. — Tamra Goettsch

Summary of presentation:

• The order is to consider an adjustment in the Marion County Fair Board Bylaws;

- The fair board established key volunteers in 2015, to promote the planning and the advertisement of the fair;
- Key volunteers help the fair board organize, plan, and implement the fair:
 - They do not have the ability to vote on fair issues or funding.
- The role of a key volunteer is similar to a fair board member:
 - o They attend all of the fair board meetings;
 - o They participate in the discussions; and
 - o They take on projects.
- The bylaws state that the fair board members will review the key volunteers once every three years;
- During one of these reviews, it was noticed that appointments of key volunteers had no term date:
- The order before the board has the same existing bylaws; it also establishes a three-year term date for a key volunteer;
- If the order is approved, each volunteer and fair board member will have the ability to be re-appointed for numerous terms;
- The Oregon Revised Statute (ORS) specifies's the period of time for a board appointment; and
- Staff will bring these terms for consideration later in the year:
 - o This enables the board to have a discussion prior to the appointment of a key volunteer or fair board member.

Board discussion:

- The bylaws are not being changed;
- In the past, the order itself did not list a term period, but if approved, the order would now list the term period for a key volunteer or fair board member.
- The term period will now match the language in the bylaws, which requires being reviewed once every three years;
- Legal counsel recommends removing the word "limit" from all areas of the order:
 - o The word is misleading;
 - Volunteers and fair board members are not limited to three-year terms; and
 - o They have the ability to be re-appointed numerous times.
- The position of a key volunteer can be the training ground to become a fair board member in the future;
- The county is always looking for individuals interested in serving as a key volunteer;
- Citizens are urged to apply if they are interested in:
 - o Agriculture;
 - o Supporting gig economies;
 - o Opportunities to bring community members together; and
 - Serving with the fair board.
- Applications can be sent to the Marion County Fair or to Marion County Community Services.

MOTION: Commissioner Brentano moved for approval of an order establishing a three-year term for Marion County Fair Board Key Volunteers and establishing term ending dates for key volunteers with the possibility for re-appointment. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.

PUBLIC WORKS

2. Consider approval of an order appointing Kent Inman, Professional Land Surveyor (PLS), as the Marion County Surveyor. – Brian Nicholas

Summary of presentation:

- Mr. Inman is a professional surveyor registered in the state of Oregon;
- The county recently hired Mr. Inman to lead the county surveyor office in the Engineering Division of Public Works;
- Mr. Inman received his professional license in 2004, when he was a staff surveyor in the Marion County Surveyors Office;
- Mr. Inman's job history includes:
 - Working for several private surveying firms;
 - o Managing his own surveying company;
 - o Serving the citizens of Lane County as Deputy County Surveyor; and
 - o Serving the City of Salem as the assistant to the city surveyor.
- The county surveyor performs a number of duties and responsibilities on behalf of the county road authority, which includes the following:
 - Maintaining all public land survey corner monuments within the county, which is the infrastructure that all surveys rely on;
 - Records and maintains records of all legal surveys, land partitions, and legal subdivisions within the county;
 - Receives and reviews all new plats and partition surveys for compliance with state and county laws, rules, and policies;
 - Maintains the standard professional practice within the local surveying community; and
 - Helps to protect the property interest of all property owners within the county.
- Mr. Inman's professional credentials and work experience qualify him to serve as the county surveyor.

Board discussion:

- Mr. Inman's knowledge and background experience will enable him to step into the role of county surveyor and be successful;
- Mr. Inman has seen processes of development and planning that are very similar to Marion County's;
- The county surveyor plays a unique role within the ORS and the surveying community:
 - They set a standard for professional quality that the surveying community can look up to; and
 - o It's a leadership role both with the county and the surveying community.

- Mr. Inman states he's excited to be back working for the county, setting a standard of excellence with surveying staff and the surveying community; and
- The statute under ORS 204.005 provides that the county surveyor shall be appointed for a four year term.

MOTION: Commissioner Willis moved for approval of an order appointing Kent Inman, Professional Land Surveyor (PLS), as the Marion County Surveyor. Seconded by Commissioner Brentano; motion carried. A voice vote was unanimous.

3. Consider approval of the Federal Emergency Management Performance Grant (EMPG) 18-524 for Marion County's Emergency Management program for the maximum amount of \$155,280 for the period of July 1, 2018 through June 30, 2019. – Ed Flick

Summary of presentation:

- The Federal Emergency Management Agency (FEMA) supports the county's emergency program with a grant that has historically been used to support salaries within the program;
- The grant is currently providing a 50 percent reimbursement for three of the four positions that are authorized within the program;
- The grant is provided annually by Congress;
- The grant has historically been paid out in two to three allotments over the federal fiscal year;
- So far, the county has received approximately \$13,000 in the state's 2018-19 fiscal year:
 - o This was applied to salaries for the months of July and August.
- The \$155,280, in addition to the \$13,000 already received, will bring the county's total up to what was received last year.

Board discussion:

- The county works hard to make sure they meet the requirements of the Federal EMPG:
 - o Maintain and update an emergency operations plan;
 - o Have an emergency operations center; and
 - o Maintain a hazard mitigation plan.
- Marion County meets all the requirements for the plan:
 - o The county would implement these requirements whether it had federal funding or not.
- Funding is reserved to support 50 percent reimbursement for the three employee's salaries.

MOTION: Commissioner Brentano moved for approval of the Federal Emergency Management Performance Grant (EMPG) 18-524 for \$155,280 for Marion County's Emergency Management program for the period of July 1, 2018 through June 30, 2019. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.
