Commissioner Cameron called the meeting to order at 9:00 a.m.

PUBLIC COMMENT

- Resides in Lake Oswego;
- Served two terms on Lake Oswego city council;
- Would like to introduce himself as a candidate for next state treasurer;
- Believes Oregon's next treasurer should have treasurer background; and
- Past Treasurer of Legacy Hospital with over half million dollars in investments.

BUSINESS SERVICES

Approve an order reappointing Terry Hancock to the Salem Foundation Distribution Committee with a term ending December 31, 2021.

HEALTH

Approve Amendment #4 with Health Resource Group, LLC to add \$12,000 in funding for additional services.

Approve Amendment #1 to the contract for services with Maxim Staffing Solutions to add \$70,000 in funding and extend until June 30, 2017.

JUVENILE

2. Accept Pay for Success (PFS) Final Report. – Faye Fagel, Brigid Zani

Summary of Presentation:

- Youth are leaving the community for higher levels of care not available in Marion County;
- Major issue identified is that of family functioning;
- Family not able to provide the structure and support that is conducive for youth to be held accountable
- Model looking at is a wraparound service that helps youth and families:
- There is not a program that exists in Marion County with the needed higher level of care;
- During 2015 legislative session, partnered with Multnomah County on House Bill 2031:
 - o Was ultimately not funded.
- A process for tracking changes is what they want to be added into the contract;
- Needed to figure out target population and criteria for service:
 - About 60 youth per year would be eligible and benefit from the higher level of care.
- Intensive home service;
- Need to change behavior of adults if you want to change the behavior of youth;
- Will serve entire county, not just Salem-Keizer area;
- Will serve Hispanic and Black youth within a culturally competent structure;
- Target intervention for youth who are at higher risk of moving on to Oregon Youth Authority (OYA);
- Rigorous evaluation process to determine the success of the project;
- Desired outcomes:
 - Reduce out of home placements including county detention, shelter care and residential OYA;
 - o Reduction in criminal referrals; and
 - Improvement in social impacts such as substance abuse and educational achievement.
- This has been an intensive year-long project with the following conclusions:
 - Marion County has the target population and numbers that make the project feasible;

- O Data that can be analyzed is available through juvenile justice information system that is used across the state; and
- OYA has robust research team that helps determine which placement and care is best.
- Major issue is funding mechanism.

Board Discussion:

- Commissioner Carlson has been involved in Pay for Success for a long time;
- Multnomah County Commissioner Judy Shiprack has also been involved;
- Commissioner Carlson wrote the grant with Multnomah County;
- Several model structures:
 - o Instead of the county contracting with a vendor, get investors to invest in product;
 - o Create advisory committee or board that oversees a "special service vehicle";
 - o Contractor only gets paid when they achieve the outcome; and
 - Second model is that part of the payment is withheld until the outcome is achieved.
- Thinks it's a solution looking for a problem;
- Doesn't see any guarantee of repayment;
- There is a need for a multi-systemic therapy that works with the youth in the home and caregivers:
 - o About 60 youth per year that would benefit from this service.
- Youth Authority has done a lot of research around predictive success rates and where youth are most successfully served:
 - Research shows that there are more youth who would have been successful without the higher level of care that they received.
- A lot of kids end up in Oregon Youth Authority because the county doesn't have anywhere else to place those with mental health issues:
 - o Need to work with the Health Department;
 - o Savings are in the long term; and
 - o Bigger issue than the 60 identified youth.

MOTION: Commissioner Brentano moved to Accept Pay for Success Final Report. Seconded by Commissioner Carlson; motion carried. A voice vote was unanimous.

PUBLIC WORKS

3. Consider a recommendation to concur in amendments to the Salem/Keizer Urban Growth Boundary (UGB). – Brandon Reich

Summary of presentation:

- City of Salem requests that Marion County concur with addition of approximately 35 acres of land in Polk County to be added to UGB for right-of-way of third bridge crossing;
- Participation necessary from Marion County because of the unique shared UGB boundary between Salem and Keizer;

- All four affected regions, Salem, Keizer, Marion and Polk Counties, must agree to the changes;
- On October 12, 2016, Marion County participated in a joint hearing with the other jurisdictions involved;
- The board left the record open until October 19, 2016 for all testimony; and
- No additional testimony was received.

Board discussion:

- Heard very little on the addition of the UGB, but a lot on why or why not a bridge should be added;
- One group said that the population forecast wasn't accurate and therefore a bridge wasn't necessary, however two bridges aren't adequate today with the current population;
- Cherriots wants a lane dedicated to transit:
 - o Expensive and wouldn't save any time; and
 - o Doesn't benefit the community.
- Environmentalist group doesn't seem to understand that idling cars would be a detriment to environment;
- Without growth there is congestion and gridlock;
- Communities with a solid transportation system are the ones that thrive;
- If the bridges go down then traffic would route to either Albany or Newberg whose bridges may also affected;
- A toll on the current bridges may help with cost;
- Received a fairly balanced testimony at the public hearing from constituents;
- The UGB expansion concurrence amongst the jurisdictions is essential because the decision to go ahead with building the third bridge has already been made:
- A few minutes extra due to traffic on the current bridge can be a matter of life or death for elderly folks who live in West Salem and need emergency medical care; and
- Population growth in areas outside of Salem is also contributing to traffic issues.

MOTION: Commissioner Carlson moved for approval of a recommendation to concur in amendments to the Salem/Keizer Urban Growth Boundary and for the staff to bring forth an ordinance reflecting the decision. Seconded by Commissioner Brentano; motion carried. A voice vote was unanimous.

4. Consider approval of the contract for services with Republic Services, Inc. for \$325,000 to provide recycling of used tires collected at Salem Keizer Recycling and Transfer Station (SKRTS) and North Marion County Disposal Facility. – Brian May

Summary of presentation:

- This is a renewal for a five year contract that expires September 30, 2021;
- Anticipated annual expense of \$65,000;
- Retroactive back to July 1, 2016;
- two escalations:
 - o Fuel fee; and
 - o Box fee.

- Republic Services will provide one empty drop box at the North Marion facility and two at SKRTS;
- 737 ton increase in tires recovered:
 - A price per unit fee has been implemented to help with cost.

Board discussion:

- Important to have a method for disposal of tires otherwise they end up in landfills or out in canyons where they are illegally dumped;
- Department of Environmental Quality (DEQ) has banned disposing of tires in landfills; and
- The two recycling locations are Molalla and Portland.

MOTION: Commissioner Brentano moved for approval of the contract for services with Republic Services, Inc. for \$325,000 to provide recycling of used tires collected at Salem Keizer Recycling and Transfer Station (SKRTS) and North Marion County Disposal Facility. Seconded by Commissioner Carlson; motion carried. A voice vote was unanimous.

5. Consider approval of the contract for services with Republic Services, Inc. for \$1,850,000 to provide hauling of waste from the North Marion County Disposal Facility to the Waste-to-Energy Facility in Brooks, OR. – Brian May

Summary of presentation:

- Contract renewal with Republic Services;
- Includes hauling demolition material to Coffin Butte or Riverbend landfill and compostable material to Browns Island facility;
- Includes management of recyclables taken to market;
- Two escalations:
 - o Haul box fee effective July 1, 2017; and
 - o Fuel recovery fee that is calculated on a monthly basis.
- About a 20 percent increase in material at the North Marion facility.

Board discussion:

• Not much of an increase in rates.

MOTION: Commissioner Carlson moved for approval of the contract for services with Republic Services, Inc. for \$1,850,000 to provide hauling of waste from the North Marion County Disposal Facility to the Waste-to-Energy Facility in Brooks, OR. Seconded by Commissioner Brentano; motion carried. A voice vote was unanimous.

FINANCE

A. Public hearing to consider adopting the first supplemental budget for fiscal year 2016-17. – Jeff White, Richard Minaker

Summary of presentation:

- Increases the budget \$13.8 million:
 - \$13.6 million comes from Net Working Capital, which is a carry-over balance from last fiscal year;
- 32 funds have changed; and
- The county has published information about the first supplemental budget and made it available for public inspection.

Board discussion:

- Had more revenue and less expenditures than anticipated;
- Have substantial Net Working Capital;
- There will be another supplemental after the first of the year; and
- In order to spend dollars set aside for Parks budget there has to be a plan in place.

MOTION: Commissioner Brentano moved to close the public hearing and adopt the first supplemental budget for fiscal year 2016-17. Seconded by Commissioner Carlson; motion carried. A voice vote was unanimous.

Commissioner Cameron read the calendar.
