6. Consider adopting an administrative ordinance amending the Marion County Comprehensive Plan by adopting a 53.10-acre amendment to the City of Turner Urban Growth Boundary (UGB) for residential and public land and rezoning land added to the UGB. –Brandon Reich Summary of presentation:

- The City of Turner has proposed an amendment to its urban growth boundary, and has held hearings on its ordinance to add 53.1 acres of land:
 - o 50.8 acres is for residential use; and
 - o 2.8 acres is for public use.
- Establishing or revising an urban growth boundary is a cooperative process between the city and the county;
- The City of Turner has requested that the county concur in the UGB amendment by ordinance;
- On June 1, 2022, the Board approved a resolution initiating amendments, and on July 20, 2022, the Board held a public hearing;
- After considering the evidence in the record the Board concurred in the city's amendment, directing staff to return with an ordinance consistent with its direction;
- On August 10, 2022, the Board scheduled adoption of the ordinance for today; and
- Before the Board today is an ordinance that concurs in the City of Turner's comprehensive plan amendment by approving an urban growth boundary amendment of 53.1 acres for residential and public land.

Board discussion:

- The City of Turner started this process last fall:
 - There was a lot of public interest, so they held additional meetings to refine the proposal; and
 - o The public had a lot of opportunities to provide input.
- The land will probably not be annexed and developed all at one time:
 - It will be annexed and developed in pieces.
- There have been other successful UGB expansions in the county; and
- County staff helped the City of Turner during the process.
