# Summary of Presentation:

- Currently operates a rental assistance program;
- Seeking the boards support to apply for the above-mentioned rental assistance program;
- Grant is in addition to serving transition age youth;
- Focus population is from ages 16 to early adulthood;
- Very critical time for youth to get support for safe, affordable and supported housing for youths with mental health challenges;
- Seeking an expansion of the existing rental assistance program;
- Would serve an additional 15 people; and
- Serves youths with a serious mental health illness coming out of the State Hospital or other residential treatment centers.

#### BUSINESS SERVICES – HUMAN RESOURCES

1. Consider recommendations from the 2016 County Compensation Board regarding compensation of elected officials. – Steve Bergmann, 2016 Compensation Board Chair, Amy Rose Fish

# Summary of Presentation:

- Compensation Board is responsible for the annual review of compensation paid to elected officials;
- Reviewed comparable market established by the Board of Commissioners from the following counties; Lane, Clackamas, Benton, Deschutes, Linn and Polk Counties;
- Recommends to the Board of Commissioners the following:
  - o For the Board of Commissioners, no change in base salary is recommended:
    - A cost of living allowance is recommended to increase their base salary up to the amount that would equal five percent from the mean of the total cash compensation should the non-represented employees receive a cost of living increase.
  - No change in base salary is recommended for the District Attorney:
    - A cost of living allowance is recommended to increase their base salary up to the amount that would equal five percent from the mean of the total cash compensation should the non-representative employees receive a cost of living increase.
  - o A one percent base salary increase is recommended for the Sheriff:
    - A cost of living allowance is recommended equal to the Undersheriff should he receive one.

o For all other elected officials, the Compensation Board recommends no change to their base salary and no cost of living increase at this time.

#### Board Discussion:

- There are a couple of different factors that lead to the one percent increase in the Sheriff's wage:
  - o Part of the statute that creates the Compensation Board also requires that the Sheriff be paid equal to or greater than the Undersheriff; and
  - There was virtually no gap in wages and with the one percent increase it creates an internal alignment with the chain of command.
- All other elected officials are at or above the mean average for their compensation salary; therefore, no cost of living increase is recommended.

**MOTION:** Commissioner Brentano moved for approval of recommendations from the 2016 County Compensation Board regarding compensation of elected officials. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.
