John Lattimer called the meeting to order at 9:05 a.m.

#### **INFORMATIONAL:**

## Discuss Revocation of Conditional Use Case #16-014/Klopfenstein

#### Summary of presentation:

- In 1978, the county approved a repair business for commercial activity in conjunction with farm use for farm equipment;
- In the conditional use, it stated that it was limited to two employees and farm equipment repair only, no repair of automobiles;
- The property was sold and the new owner who hired the current person to run the business, which morphed into automobile repair;
- Code enforcement received a complaint about the business:
  - As a result, the property owner filed a conditional use to amend the conditions of the previous conditional use.
- The county approved the conditional use with 75 percent of farm equipment repairs and 25 percent vehicle repairs:
  - The applicant didn't believe that they could meet the terms of the conditional use.
- The hearings officer denied the request due to the fact that the business had been vacated at one time:
  - The applicant appealed the decision to the board:
    - The applicant provided documentation that the business was continually being operated;
    - The applicant proposed to amend the conditions:
      - Self-report March of every year of the previous year's breakdown of farm related repair to non-farm related repair;
      - The county cannot automatically revoke the conditional use unless the business falls under 50 percent of farm related repairs two years in a row:

- In 2017, 70 percent of the business was non-farm related;
- Last year, 63 percent was non-farm related; and
- The applicant has not met the 50 percent requirement.
- Mr. Fennimore plans to revoke the conditional use:
  - The applicant can still operate under the original conditional use.
- The applicant can appeal the decision to the hearings officer and come before the board again.

## Board discussion:

- The applicant proposed the conditional use in order for the board to approve it;
- The applicant would need to reapply to set different conditional use standards;
- A neighbor complained about the amount of vehicles that are on the property;
- The applicant has not responded from letters that Mr. Fennimore has sent;
- Under the code, the planning director has authority to revoke conditional uses; and
- Mr. Fennimore and Code Enforcement will request a meeting with the applicant to set a plan for shutting down the business.

# **Review Rural Industrial Exemption Authorization Applications**

## Summary of presentation:

- In 2016, the legislature passed a rural and property tax exemption for industrial investments with the help of Marion County;
- In 2018, Marion County created an ordinance outlining the rural and property tax exemption;
- The county has received three applications that fall under the ordinance;
- The tax exemption grants industrial investments in rural areas in Marion County;
- It is a 100 percent tax exemption up to three years as long as the applicant gets a concurrence of 75 percent of the taxing value entities;
- The county is the initiating jurisdiction:
  - School district; and
  - Fire district.
- The applications will come before the board at board session as a resolution;
- The DK Fab, Inc. application is for \$4 million of industrial equipment:
  - May not complete their process due to a fire.
- Hopmere Cold, LLC is building a 24,000 square foot building for their business; and
- Marion AG has proposed a 75,000 square foot building.

## **Board discussion:**

- If Marion County approves the exemption, it does not guarantee the business will get the tax exemption:
  - 75 percent taxing district approval is needed.
- The following qualifications have to be met in order to be approved:
  - \$1 million investment;
  - An employment test where the business has to add either one employee, or 10 percent to the workforce; and
  - Newly constructed or installed property.
- Gives the county the ability to encourage businesses to make investments and gives them tax breaks for three years; and
- Commissioner Brentano will abstain from voting for this at board session due to a conflict.

## Coordinated Care Organization (CCO) Discussion

## Summary of presentation:

- PacificSource wants the county to put together a Memorandum of Understanding (MOU) by April 1, 2019, for them to submit to the Oregon Health Authority:
  - PacificSource stated it was required.
- Need direction from the board;
- Polk County adopted a fairly general MOU that outlines requirements;
- Believes the board should do the same thing, but with changes;
- The CCO's have to show provider adequacy for both the behavioral health provider system, and their physical health provider system;
- The obscure report provided is a network delivery report;
- A prospective provider needs to be submitted by April 1, 2019;
- Application is due April 22, 2019;
- The MOU has been adopted by PacificSource and Marion-Polk Coordinated Care Organization;
- There is a citing that has been added in the MOU that references the local health authority's role that Marion-Polk Health Plan; and
- This discussion will need to move to Action.

**MOTION:** Commissioner Brentano moved for approval of moving Coordinated Care Organization Discussion under Action. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.

## Consider approval of a Memorandum of Understanding regarding Coordinated Care Organizations

## Summary of presentation:

- Legal Counsel spoke with Polk County's Legal Counsel and they stated that they were surprised by the MOU:
  - Polk County put together a general MOU.

- Previously, Marion County didn't believe that they had a strong enough voice in the governance of the CCO;
  - The county was not adequately compensated for care they were providing.
- The MOU acknowledges that the county is a provider;
  - Ms. Moller asked PacificSource for a timeline:
    - The application is due April 22, 2019;
    - The state of Oregon will make decisions on who they will contract with in early July;
    - $\circ$  Between July and September 2019, the contracts will be initiated; and
    - Between September and December 2019, the CCO's will be initiating their own contracts with the community.
- This MOU satisfies all requirements with the two CCO's between now and April 22<sup>nd</sup>.
- Trillium did not initiate a MOU, but Marion County will draft one:
  - Trillium has been purchased by a national company; and
  - OHA had agreed to allow any current CCO to apply.

The commissioners recessed at 9:39 a.m. The commissioners reconvened at 9:59 a.m.

- All of the MOU's are identical;
- The MOU states that the county will support their application:
  - The county is a licensed provider; and
  - $\circ$  The county will provide a letter of support if asked to do so.

**MOTION:** Commissioner Brentano moved for approval of the proposed Memorandums of Understanding with Marion-Polk Coordinated Care, Inc., PacificSource Health Plans, and Trillium Community Plan. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.

- Rob Bovett emailed John and Jan regarding deputy district attorneys wanting to be added under police and fire in PERS:
  - Adding them to the definition of a police officer;
  - Mr. Bovett is completing the fiscal impact by Tuesday;
  - There is a \$77,297 financial impact to Marion County for the first year; and
  - $\circ$   $\;$  Will be up for discussion on Wednesday.

House Bill 2974:

- Representative Evans bill;
- Creates the Bridge District;

- Putting language together to propose getting an exemption again; and
- Commissioner Cameron will meet with Senator Roblan and Elise Brown on Wednesday, April 3<sup>rd</sup>.

Senate Bill 451:

- Caucus meeting on Thursday, April 4<sup>th</sup>.

Court Care Bill:
