INFORMATIONAL:

Discuss Approving a Sale or Transfer of Tax Foreclosed Property on Farmland Lane to the City of Keizer

Summary of presentation:

- During the plat review process of a subdivision that was proposed in the City of Keizer, the Assessor's Office discovered that a portion of property that was perceived to be public right-of-way, was actually owned privately by Keizer and Marion County;
- Keizer acquired a portion of Farmland Lane from Marion County:
 - o Marion County acquired the property through the foreclosure process.
- The deed to Marion County was acquired one way, and when it was conveyed to Keizer, it was conveyed using a different description:
 - o Only conveyed .75 of the property to Keizer.
- Keizer granted all of the land owners adjacent to Farmland Lane private access easements rather than dedicating it to the public;
- Marion County owns the east end of Farmland Lane, which is a 50-foot by 75-foot strip;
- Staff is requesting to grant Keizer the remaining property; and
- Keizer will go through a council action and dedicate the whole road to the public.

Discuss Submitting a Writ of Assistance to the Court for Tax ID #R97996 and #M127796 Located at 20853 Filbert Street NE, Aurora

Summary of presentation:

Foreclosed on the property in January 2018;

- The son of the previous owners moved in after his parents passed away and took over the property knowing it was foreclosed;
- There are abandoned vehicles on the property:
 - o Garbage;
 - o Stolen water and power resources; and
 - Police have been called due to heavy foot traffic to the property and noise disturbances.
- The son has not been receptive of any help the county has offered;
- Trying to get a Writ of Assistance submitted to the court to help remove the son from the property:
 - o Staff wants to get the property ready for auction in September 2019.
- The city of Aurora has called the county several times regarding the nuisance property; and
- The son is trying to sell the property even though he does not own it.
