INFORMATIONAL:

Marion County Parks Update

- Russ Dilley, Brian May

Summary of presentation:

- Hoping to have most of the North Fork parks open by Memorial Day weekend;
- Public Works hires eight seasonal parks staff:
 - They place nine fee boxes out every morning, seven days a week;
 - o Will do basic park maintenance;
 - o Continue with mowing;
 - Vegetation management;
 - o Painting of restrooms, park gate, and picnic tables;
 - Bridge and stairway repair; and
 - Parking lot maintenance.
- Public Works does not want to go backwards with the fee collection:
 - Parking fees from the park's parking lots collect \$31,000, and street parking fees collect \$10,000 seasonally; and
 - The fee is \$5 a day and the annual pass is \$30.
- May be seeing a lot of impact with full parks if Mongold State Park closes;
- Need to move forward with Auburn Park Conversion Program;
- Can do split shifts for temporary workers with minimal staff as possible;
- Anticipating no financial changes for 2020; and
- Able to keep full-time staff.

Board discussion:

- The commissioners would like to open the parks:
 - o May 15th date;
 - Keep the playgrounds closed until Phase 2 is approved by the governor;
 - Open the park bathrooms; and

- Keep collecting parking fees.
- Bear Creek Park Host is needed:
 - \circ Normal opening date is May 1st; and
 - The commissioners would like the campground opened.

COVID-19 Update:

Summary of presentation:

- Eastern Oregon commissioners are wanting to push back with opening restaurants on the April 30th date:
 - Restaurants are opening.
- Need to set a meeting with Travel Salem, hotels, environmental health, and the restaurant industry, to do some marketing strategies and help businesses;
- Try and create a model to follow social distancing rules;
- LC-29 is the COVID-19 legislation:
 - Section 60 covers local governments; and
 - There are rumors that other issues have been added to the agenda.
- The governor may be issuing an executive order next week that helps all local governments with their deadlines and timelines with budgets:
 - o Land use decisions; and
 - How to give public testimony.
 - There is a concern with federal money not getting to the counties;
- Business Grant Program Update:
 - Willamette Workforce Partnership (WWP) will be handling the first \$200,000 in grants;
 - The county is handling the rest of the money forward;
 - The county is waiting on the business information from WWP to be transmitted so the checks can be cut today;
 - Legal Counsel has written the board order stating that the first \$200,000 awarded will be between \$1,000-\$5,000, and follow the exact same criteria:
 - Any application thereafter, assuming that it meets the criteria, will get \$1,000 if they qualify.
 - Willamette Workforce Partnership is going to email the grant award recipients today;
 - Ten to 15 percent of the applications are incomplete;
 - WWP is looking to email the remainder of the applicants today whether or not they have been approved:
 - The commissioners would be hesitant communicating with the \$1,000 award recipients;
 - There are 190 validated businesses so far; and
 - WWP and the board's office will add information to their websites regarding the large influx of applications received.
- A Marion County Dashboard for COVID-19 is on the Marion County internet; and
- The Salem Chamber of Commerce started a Facebook site called, "Salem Eats":

• It lists area restaurants that offer takeout, or other creative take-andbake options.
