Jan Fritz called the meeting to order at 9:00 a.m.

INFORMATIONAL:

Discuss the Aurora-Donald Interchange Area Management Plan

- Janelle Shanahan, Brandon Reich

Summary of presentation:

- The Oregon Department of Transportation (ODOT) has been developing this plan over the last several years;
- In 2019, they involved the county in their process of bringing it through to the stakeholders;
- The plan addresses and plans for the future conditions at the interchange;
- There are traffic and safety issues at the interchange;
- ODOT has selected the Diverging Diamond Plan;
- Due to funding, they have to develop it in two phases;
- Phase one has been identified and will be started in 2022;
- In order to have it be approved through the county's process, it needs to be included in the county's Transportation System Plan;
- ODOT is asking the county to adopt their plan in order to move forward; and
- A public hearing is scheduled for September 30th on the matter.

Board discussion:

- Encouraging Public Works to complete the total project; and
- Public Works hasn't heard any pushback from the Department of Land Conservation and Development.

Review Revisions to Policy 304 – Americans with Disabilities Act (ADA)

- Lisa Trauernicht, Justine Flora, Don Alexander, Michelle Shelton, and Scott Norris *Summary of presentation:*

- There are three procedures that go with this policy:
 - o Employment;
 - Public Access to Programs and Facilities; and

- Public Rights-of-Way, which is a new procedure:
 - Part of Public Works Transition Plan.
- There are a few changes to the policy;
- Language changes;
- Changed department from Business Services to Human Resources;
- There were no changes to the employment portion of the policy and procedures;
- The Public Rights-of-Way procedure covers the Public Works Transition Plan:
 - Part of the plan requires establishing a request for accommodations and grievance procedure;
 - This will allow individuals accommodations for any rights-of-way ADA facilities, which would include the following:
 - Curb ramps;
 - Signalized intersections;
 - Push-button signalized intersections; or
 - Any other types of sidewalk obstructions that would create an issue with people with disabilities in the rights-of-way.
 - The procedure allows individuals to request an accommodation, which would be followed-up by a grievance process;
 - o Typical accommodations include reprioritization of ADA projects;
 - There is a steering committee that is providing development of the Transition Plan:
 - There are representatives from the ADA community:
 - Cherriots;
 - Salem-Keizer School District;
 - Northwest Seniors and Disabilities; and
 - Garten.
 - They will be presenting the prioritization criteria at the next focus group meeting, which will allow them to help develop a schedule of needs.
 - The grievance procedure is one piece of the overall plan that relates to the rights-of-way, including prioritization of projects:
 - Matching it up with existing road projects.
 - The ADA legislation has a list of requirements:
 - Has a methodology for establishing priorities;
 - Has an ADA accommodation request process; and
 - Has a grievance process.
 - Sidewalk repair is a grey area regarding where the responsibility lays:
 - The county ordinance requires for the homeowner to maintain the sidewalk in sound working condition, not to upgrade or improve the condition.
- The steering committee focus group meets next week:
 - After that meeting, Public Works will put together a draft ADA Transition Plan;
 - Will bring the draft before the board for review;
 - o The draft will be completed by the end of the year; and
 - Will bring the plan for final approval before the board in January or February of 2021.

• The policy will be put on hold until Public Works is further along in their ADA Transition Plan.

Board discussion:

- As part of the Transition Plan, the county has done a self-assessment of all the curb ramps in the county right-of-way; and
- The commissioners believe that the Public Rights-of-Way procedure is legally binding, which may cause some issues:
 - The accommodations should be reasonable.

COVID-19 Update:

Summary of presentation:

School District Plans for Reopening:

- Half of Salem-Keizer School District plans have come in and been reviewed; and
- All of the smaller school districts in the county have been reviewed.

OTHER:

Barb Young:

- Marion County Health and Human Services (MCHHS) has drafted a letter of support and they are asking the commissioners to sign:
 - Asking the Oregon Health Authority to get more testing capacity for Marion County and get testing results quicker.

Jan Fritz:

- Working with MCHHS doing research on long-term care facility programs around the country:
 - Looking into paying wages for low income workers at the facilities.

Kevin Cameron:

- Received a call from a local business owner stating that their representative was in a meeting with the governor's office and it was conveyed to them that they need to put pressure on local elected officials to enforce the governor's rules:
 - If that doesn't happen, then she would shut down businesses again.
- Commissioner Cameron believes that the governor is putting pressure on other organizations to put pressure on local officials in order to enforce mandates;
- Restaurants, bars, and salons are not the places where the virus is spreading:
 - o Family gatherings;
 - Long-term care facilities; and
 - Gatherings in an uncontrolled environment are where cases are spreading.
- Commissioner Willis stated that he was on a call with the governor's office:
 - The governor stated that the metrics are not being met for schools reopening:

- Local governments need to start enforce wearing face masks, or businesses will need to be shut down again.
- All of the county chairs stated that they do not have the resources to enforce the mask rule;
- o Less than one percent of cases come from restaurants and bars;
- The governor accepted what the group said:
 - Stated that she would put more resources towards helping people quarantine.
- At the press conference the next day, the governor reversed her position from the meeting the previous day; and
- The commissioners are not in favor of using resources to enforce the mask mandate when legitimate businesses are not the source of significant risk for COVID-19 transmission.

Jolene Kelley:

• Asking the commissioners if they are interested in holding virtual town hall meetings.
