# Review Proposed Employee Social Security Payroll Tax Deferral

#### Summary of presentation:

- On August 8, 2020, President Trump signed a series of memos to have employers defer the employee share of social security taxes for those who make less than \$4,000 every two weeks;
- The effective date is September 1, 2020;
- The taxes will be deferred, not waived;
- Beginning January 1, 2021, there will be a repayment requirement:
  - o The president is hoping to have the U.S. Department of Treasury waive the repayment plan.
- The memo does not provide guidance, it does direct the U.S. Department of Treasury to issue guidance on how to implement the president's memo;
- Most employers have been debating whether or not the memo is legally enforceable:
  - If it is an opt-in or opt-out;
  - o If employees have the choice to opt-in; and
  - o What the terms of the repayment are.
- The county's Information Technology (IT) staff is not able to reprogram
  Oracle in order to have the program not pull social security taxes from
  paychecks;
- IT has talked to Oracle and they have indicated that they are working on a patch to make it possible;
- Late Friday, the U.S. Department of Treasury and the IRS did come out with some guidance:
  - Suggests that employees would pay back the deferral from January through April 2021.
- The tax deferment is optional for employers;

- Michelle Shelton spoke with MCEA union leadership and they stated that their employees are not interested in the deferment; and
- It is staff's recommendation not to implement the tax deferment at this time.

#### **Board discussion:**

- If the repayment is forgiven, then the commissioners would like to figure out how the county could do the tax deferment plan and have it be retroactive for employees;
- There will not be a decision on waiving the repayment until after the election;
- There was a deferral option to employers, but the county decided to forego it due to not knowing the repayment terms; and
- The county is not aware of any entity that is participating in the tax deferment plan.

### **COVID-19 Update:**

# Summary of presentation:

Tamra Goettsch:

- Requesting an extension of Ms. Goettsch's and Ms. Potter's authority to waive late fees for dog licensing due to COVID-19;
- There are delays in veterinarian appointments, which delays rabies vaccinations:
- The dog shelter cannot renew dog licenses without an active rabies certificate;
- Asking for the extension to go through October 31, 2020; and
- It is currently on the consent calendar for Board Session this Wednesday.

#### **Board discussion:**

- Dog licensing is down in Marion County;
- There is an increase for walk-ins for licensing at the Community Services Department;
- The commissioners would like the Dog Shelter put out a press release regarding the extension of waiving late fees; and
- There are fewer dogs in the shelter:
  - o There is an increase of fostering dogs.
