INFORMATIONAL:

Project Apofiki Update and Next Steps

- Tamra Goettsch and Jason Schneider

Summary of presentation:

- This is a 700,000 square foot facility, which will cost \$80 million, and be built in Woodburn;
- Woodburn is excited about the project;
- Apofiki, through Business Oregon, has expressed additional interest and is looking at timelines to see if the county is still interested and engaged;
- If the county is still interested in the project, a public hearing would need to be scheduled at the end of November, which would push back wrapping up the entire process; and
- Project Apofiki is requesting another letter of reaffirming commitment that the county is interested in the project.

OTHER:

Tamra Goettsch:

- The Volunteer Organization Assisting Disasters (VOAD) training was last Friday:
 - The training is being provided by FEMA;
 - It is a long term recovery team;
 - Typically government entities are not part of the team;
 - o The team becomes a 501(c)(3);
 - Have branch committees that take on donations;
 - Have construction committees;
 - Ms. Goettsch encouraged all nonprofits from the county to attend the training;
 - o It is a training to understand the infrastructure;
 - Goal is to bring it toward a centralized effort;
 - o Brings forward a community voice; and

- o The next meeting is Friday, October 23rd at 9:00 a.m.
- · Already seeing fatigue in the grassroots SIT team; and
- Attended the Construction Alliance meeting last week:
 - o More than 102 businesses are involved; and
 - o More than 60 companies signed up to build the fire department, city hall, and community center in Detroit.
