# Management Update Minutes

## INFORMATIONAL:

## **Oregon Department of Forestry Presentation**

#### Summary of presentation:

- Half of the Santiam State Forest was in the footprint of the Beachie Creek Fire;
- The annual report provides information for all of the 15 trust counties where the department manages state forest lands;
- State forest is responsible for managing 730,000 acres of forest lands around the state:
- The Oregon Department of Forestry is charged with managing those lands for raised permanent value;
- Two-thirds of the money from timber sales goes to the counties:
  - o The remainder stays within the Department of Forestry, which is used to fund their operations.
- The Santiam State Forest covers three counties:
  - Marion County;
  - o Linn County; and
  - o Clackamas County.
- The Santiam State Forest is more than 50,000 acres:
  - o 25,000 acres was within the footprint of the burn;

- o There is a good portion of the forest that did not burn, or only suffered a low intensity burn:
  - There were 13,000 acres that suffered high intensity burn.
- The department wants to clear cut more than 3,500 acres of high intensity burn area that is salvageable;
- Making sure roads are safe;
- Re-establishing fish passages;
- Making recreation areas safe;
- 2019 financial revenue:
  - Harvested 238 million board feet:
  - o Timber value decreased by \$25 per 1,000 board feet;
  - o Total revenue was \$107.5 million:
    - \$70 million was distributed to the counties; and
    - \$38 million was distributed to the Department of Forestry:
      - Actual operation costs were \$39 million.
  - Had 57 timber sales, which is estimated to sell at \$209 million board feet and bring in \$82.7 million; and
  - Estimated to produce another 215 million board feet and \$83.4 million in total revenue.
  - o Social Benefits:
    - \$539,000 was distributed to Marion County.

#### Board discussion:

- The fire cost was an accurate number for this year:
  - o Every year it is recalculated; and
  - The assessment rates may go up in the years to come based on the fire patterns.
- Ms. Dent was not engaged in the fire conversations:
  - o They were happening in a different division.

## **Marion County Fire District 1 Presentation**

## Summary of Presentation:

- Marion County Fire District 1 is a special district responsible for fire protection in the unincorporated areas around the cities of Salem and Keizer:
  - o Also responsible for the communities of Pratum:
    - MacLeay;
    - Lake Labish:
    - Brooks:
    - Clear Lake:
    - Middle Grove; and
    - Four Corners.
- Services more than 50,000 residents;
- Has eight stations;
- On track to respond to more than 8,100 calls in 2020;
- Responds to two-thirds of the calls in the Urban Growth Boundary, which brings in the majority of their revenue;

- Provides ambulance transport services throughout the county through mutual aid agreements;
- In May 2020, the fire district went to the voters for an increase for the local option levy, which was defeated;
- In November 2020, the fire district regrouped and went to the voters for a status quo local option levy, which was also defeated:
  - o This was the first time in the fire district's history that a levy or a bond has failed.
- The levy accounted for 30 percent of the revenue, which was \$2.4 million annually;
- In the process of laying off one-third of staff:
  - o Includes 12 firefighter paramedics and battalion chiefs.
- Will take the fire district back to pre-2007 staffing levels;
- There are more than 50 volunteers, which is half of what was on the roster in 2001:
- The fire district still plans to keep the ASA agreement;
- The district has met with the City of Salem and surrounding fire departments regarding the staffing shortage;
- Starting January 1, 2021, there will be eight personnel per day staffed;
- The board is considering going out for another local option levy in 2022 due to it being a rural district trying to provide urban services:
  - One of the largest combination departments in the state based on land:
    - Population; and
    - Call volume.
  - Lowest for tax rate and budget.
- Looking for support from the commissioners; and
- Would like to explore being added to the service districts, like the Sheriff's Office has.

#### Board discussion:

- The fire district was rated by the insurance services office, which they only rate every 10 years, so individuals homeowners insurance should not increase; and
- The fire district is formally closing two stations:
  - o Lake Labish; and
  - o Macleay.

## **Discuss Application of Proration of Property Taxes**

## Summary of Presentation:

- Commissioner Cameron was contacted by a constituent regarding a letter that they received stating that they did not qualify for the proration of property taxes;
- This is due to the current state statute of how property taxes are calculated;
- Mr. Rohlfing had previously presented to the board the statutes and the issues regarding the statutes;

- The real market value of the property has to fall below the assessed value to receive any relief;
- The constituent's property is located on the North Fork River, which means that the land is valued high:
  - The land is assessed at more than half of the total value of the property; and
  - o If the structures are removed, the real market value does not fall below the maximum assessed value.
- The assessed value is not broken out by land and improvements:
  - It is an assessed value for the entire property.
- The assessed value is \$107,000:
  - o Prior to the fire, the real market value was \$261,851; and
  - o The property owners were paying taxes on the assessed value.
- There are eight staff dedicated to reassessing damaged properties in the canyon;
- The constituent has removed everything off of their land after the fire:
  - Septic; and
  - o Well.
- The constituent will be paying taxes on \$50,000 versus the \$107,000;
- There are three different legislative concepts:
  - o There is a legislative concept that went through Senator Girod's office.
- The commissioners would like to sit down with the constituents to better explain the issues of why they are not receiving a proration of property taxes.

## Discuss Project Apofiki and Negotiating the Usage of the Community Service Fee:

## Summary of presentation:

- The City of Woodburn asked to begin a conversation around a Community Service Fee;
- It would be in lieu of \$14.7 million in taxes that the county would forego should they go through a strategic investment program;
- The county would receive a \$3.5 million Community Service Fee, which could be distributed based on an agreement between the taxing districts that would be normally receiving those funds;
- The county would forego \$2.1 million in exchange for just over \$900,000;
- The City of Woodburn would forego \$4.5 million in exchange for \$1.8 million;
- This is meant as a starting point for a discussion of a community service fee;
- Business Oregon has not laid out how the process would work; and
- Looking for direction from the board.

#### Board discussion:

- The service districts that were left off were the education districts that were made available by the state:
  - o Looking at districts that would be losing revenue.
- This is a proposal by Woodburn;
- Project Apofiki would not be on the tax rolls for 15 years; and

• Will set a joint Work Session at the first of the year when the new commissioner starts.

#### BEACHIE CREEK FIRE UPDATE:

#### Public Works:

- Had the initial scoping meeting with FEMA on December 3, 2020:
  - Everything needs to be turned in to FEMA no later than February 1, 2021.
- Set up a meeting schedule with FEMA to go over damage inventory on Monday's at 11:30 a.m.:
  - o Will always discuss Category B at that meeting.
- Public Assistance registration deadline is December 13, 2020:
  - Ms. Kelley talked with Oregon Emergency Management about sending out a public announcement.
- The Oregon Department of Transportation (ODOT) is still bidding the trash cleanup, will follow up for an update;
- The tree removal protest was retracted and contracts will be signed this week:
- Can remove debris up to 18 months from the presidential declaration;
- Tree removal:
  - o ODOT will have an agreement with the counties for tree removal;
  - Public Works staff will meet today to staff a project management team to manage tree removal;
  - o The county will be present at the tree removal;
  - The county hired an arborist under Category A for North Fork Road and he marked the entire corridor:
    - Gates Hill Road.
  - Only removed trees upstream with Gates Hill Road on North Fork Road:
  - ODOT or the electric utilities mowed down the trees on Railroad Avenue;
  - ODOT will provide an arborist and mark the trees and the county will validate if those trees should be cut down;
  - o The county's contracted arborists will follow the ODOT arborist; and
  - o If there is a damaged tree on private property, the county will reach out to the property owner to get approval to remove.

## **Building Inspection Division:**

- Have received many permits for replacing and repairing dwellings;
- Received permits for manufactured homes;
- Have received authorizations and permits to repair;
- There is not much of a turnaround time from Public Works;
- Septic permit turnaround times have been fairly guick; and
- Interested in looking at offering relief for permits for second homes.

#### COVID UPDATE:

Have received 332 grant applications as of this morning.

• Received an email from Jayne Downing stating that they have been accepted for phase two of Project Turnkey, so they are moving ahead in the process.
