BOARD OF COMMISSIONERS

- Ms. Freauf is a current Woodburn resident and has strong ties there:
 - o Rural communities get lost and she wants to represent these communities.

- Members include ambulance service providers:
 - o 911 representatives;
 - o Hospital staff; and
 - o Law enforcement personnel.
- Mr. Mullen is the Assistant Chief for the St. Paul Fire District:
 - o Represents the smallest Ambulance Service Area (ASA);
 - o Has been a committee member since 2001; and

- Mr. Shepherd is the Assistant Chief with the Jefferson Fire District:

- Issues that the committee has been working to address include drop off times at Salem Hospital, and quality and system issues.

- Over 15,000 individuals were processed last year at the jail;
- Many have mental health and medical issues;
- Commander Larson shared a story about an individual who had been a problematic, frequent flyer of the criminal justice system:
 - o All four divisions of the Sheriff's Office served this client;
 - The probation officer was patient, caring, and understanding when dealing with the client and was able to place them in a treatment facility in Central Oregon; and
 - The individual sent a short thank you letter to the Sheriff's Office regarding the contact and services they received through the county in the corrections system.
- Commander Kast highlighted the efforts of the patrol deputies over the past week, which is just an example of the types of calls received throughout the year:
 - Appreciates the support received from the board and the citizens of Marion County.

Board discussion:

• The commissioners expressed their thanks and gratitude for the nurses out at the jail and the employees in the Sheriff's Office.
