# PUBLIC WORKS

A. Public hearing to consider Zone Change/Comprehensive Plan (ZC/CP) Case 17-004/Helm. – Joe Fennimore

# Summary of presentation:

- A request to change the comprehensive plan designation from Primary Agriculture to Farm Timber and to change the zone from Exclusive Farm Use (EFU) to Farm Timber on 53 acres of land located in the 16,200 block of Emerald Green Lane SE, Jefferson;
- The property is undeveloped and generally well-stocked in timber;
- Properties to the north, west, and south are zoned EFU and in various types of farm use;
- Land to the east is zoned Acreage Residential and contains rural residences on acreage lots;

- The hearings officer held a public hearing on the request on November 29, 2017:
  - o Issued a recommendation that the board grant the request on March 6, 2018.
- All comprehensive plan amendments must be consistent with statewide planning goals:
  - o In order to evaluate the proposal against goal 4, Forest Lands, the hearings officer looked at the description of the farm timber designation:
    - After a detailed analysis, the hearings officer concluded that based on the use of the property, the soils, the size, and topography, the site shares sufficient characteristics to allow the farm/timber designation;
    - Practical restrictions on the property do make it wholly productive for solely farm use or solely forest use; and
    - The hearings officer concluded that the proposal meets goals 3 and 4: and
    - A goal exception is not required.
- The hearings officer then reviewed the request against the applicable comprehensive plan policies and zone change criteria:
  - The hearings officer concluded that they are satisfied.

# SHERIFF'S OFFICE

B. Public hearing to consider adding law enforcement services as an additional service provided by the East Salem Service District. – Sheriff Jason Myers, Scott Norris

Summary of presentation: (See Attachment A)

- Area around Chemeketa and Four Corners area;
- Both areas combined is 5.59 square miles;
- 54 percent of calls for services comes out of this area;
- Dramatic increase in calls for service in this area;
- City of Salem has 11.4 officers per 10,000 residents:
  - o City of Keizer has 10.7 officer per 10,000 residents; and
  - o Marion County has 8.4 deputies per 10,000 residents.
- Population has continued to grow, yet the amount of deputies remain the same;

- Response times are increasing;
- Discretionary time is going down;
- \$10 per household and per acre for commercial properties would provide 10 deputy positions that would be exclusive to the east Salem area;
- Enhancement to the patrol staff;
- Deputies would be specific to the Hayesville and Four Corners area;
- It takes five deputies to staff one position seven days a week, 24 hours a day, and 365 days a year;
- Five deputies would be assigned to the Hayesville area:
  - o Five deputies would be assigned to the Four Corners area.
- Geographic deployment:
  - o Benefit:
    - Takes ownership over the community;
    - Able to better deal with livability and quality of life issues within the community;
    - The deputies take ownership of the area; and
    - Ability to work with the community to focus on issues.
- This is the first public hearing;
- The purpose of the hearing is for the board to determine whether the territory of the East Salem Service District will be benefitted by the addition of law enforcement services;
- If the board concludes that the district would be benefitted by the addition of law enforcement services, an order will be drafted for the board to sign next week to schedule the second public hearing, which will be scheduled for June 6, 2018:
  - o The board may issue an order formally adding law enforcement services to the East Salem Service District.

#### **Board discussion:**

- The greatest demand on resources is in the East Salem Service District area:
  - o Continued to see growth in that area;
  - The population of Hayesville and Four Corners would be equal to the size of the City of Keizer;
  - o The Sheriff's Office cannot make it to the outlying area of the county because there is such pull of resources into the East Salem Service District;
  - o Helps the Sheriff's Office to focus on this area;
  - o Address concerns brought forward by residents in the area; and
  - o Provides relief for general fund deputies supporting activity in the East Salem area, but also give fair policing to the outlying areas as well.
- The commissioners read into the record emails individuals sent in for support and opposition (See Attachment B & C).

  - o If there is an emergency, the deputy that is dedicated to the East Salem area would respond; and
  - Will be relieved by other deputies if it's a continued investigation.
- The neighborhood association is very excited about having a dedicated officer.

#### Greg Leo:

- Serves on the Marion County Public Safety Coordinating Council and the Marion County Sheriff's Citizen Advisory Committee;
- Speaking in strong support;
- Will benefit the residents in the area;
- Puts additional resources in play for the law enforcement needs of the county; and
- Sheriff's Office does a great job protecting the community.

#### Kevin McGrory:

- Four Corners resident of 37 years:
- Has seen his neighborhood go from country to urban;
- Attended the town hall meetings;
- Neighborhood has 35 percent less protection and safety than residents who live two block away and within city limits;
- Allows his neighborhood to have community policing;
- Looked over the cost benefit analysis:
  - o The fee is more cost effective to Mr. McGrory personally.
- The money will provide two additional substations;
- Money doesn't go to a general fund;
- Improves livability;
- Improves property value;
- Understands it will take a year and a half to two years to fully staff the area;
- Realizes that \$.33 a day may be a lot of money to those on a fixed income;
- Public safety is the core of everything; and
