Description of Background:			From time to time, a pro tem justice of the peace is needed to handle cases when the Marion County Justice of the Peace is unavailable or when a conflict of interest may arise. Pursuant to ORS 51.260(2), the board of commissioners has the authority to appoint a justice of the peace pro tempore to serve in a justice court. Todd C. McCann is a practicing attorney in Oregon who also serves as municipal court judge in Monmouth and Adair Village, Oregon. Todd C.
