WHEREAS, on March 17, 2017, Warpaint Paintball applied for a small mass gathering permit on property owned by Buyserie Farms LLC, for a small outdoor mass gathering on May 4 through May 7, 2017, on approximately 104 acres in an EFU (Exclusive Farm Use) zone located at 20794 French Prairie Road NE, St. Paul.
