**WHEREAS**, the Parole and Probation Officers of Marion County embrace Evidence Based Practices, utilize the Effective Practices in Community Supervision and are a true factor for positive change; and

**WHEREAS**, it is important that all Marion County citizens know and understand the duties, responsibilities, hazards and sacrifices of their Parole and Probation Officers.

**THEREFORE**, be it resolved that we, the Commissioners of Marion County, do hereby proclaim July 15-21, 2018 as:
