# Marion County Economic Development Advisory Board August 10, 2016 Meeting Minutes 555 Court St NE, 5<sup>th</sup> Floor Salem, OR

Call to Order: 3:35pm

Agenda Item: Welcome, Introductions & Announcements

Information/Discussion: Morris called the meeting to order, asked for introductions. Action: None.

**Agenda Item: June Minutes** 

Information/Discussion: Morris presented the minutes and called for comment; no discussion was held.

**Action:** A motion was brought forth by Burich to approve the June minutes; a second was made by Hill. The motion was voted on and approved unanimously.

#### Agenda Item: Updates – Canyon, Grants, and Economic Development Summit

Information/Discussion: Cameron provided an update on recent meetings in the N. Santiam River Canyon regarding the Detroit Lake water levels and impact on the recreation season. The prior week the water levels were about thirteen feet below fill levels requiring boats to be out of the docks in about two weeks; prime business time for the marinas have been shortened by about two months. Cameron recently took Kurt Schrader on a tour of the industrial lands in the area, followed by a boat tour of the marinas to discuss the economic vitality of the area and the impact the lake water level management has on the tourism industry. A community meeting was held with approximately 200 attendees; Marine Corps gave a presentation and the Sheriff's Office received a standing ovation for their service in the area. Marine Corps agreed to exploring dredging under the docks as a potential solution, dredging would allow the docks to move in and out as the lake levels change. A meeting was held with the Marine Corps and marina owners on August 9th to discuss the permitting process. Cameron expected an update by the end of the week. Cavazos shared that Becky McCray was confirmed for the rural economic development summit which has been rescheduled for March 7, 2017 to allow more time for planning. She is working to build the planning committee and expects more details to be available in October. Cavazos shared inquiries are coming in on the FY16/17 business grant opportunities and plans to have the business grant request for applications released by September 26, 2017 with minimal changes to the criteria. The Grant and Loan Ad Hoc Committee will continue to meeting and present a full report later in the fall.

## Agenda Item: SEDCOR 4TH Quarter Report

**Information/Discussion:** Freeman had a last minute conflict and was not present to present the report. The report was included in the packet for individual review. Cameron shared that the Ground Breaking Ceremony for Henningsen Cold Storage is on the 18<sup>th</sup> at 10:00am and all are welcome to attend.

### Agenda Item: Travel Salem 4<sup>th</sup> Quarter Report

Information/Discussion: Morris presented Travel Salem's fourth quarter report highlighting multiple successes in their marketing and communications activities including a 191% increase in their Facebook reach supported by Facebook marketing campaigns, and the launch of their Pinterest account. Morris discussed the potential future business leads and bookings report, noting that Travel Salem has already confirmed booking of 16 events for 16/17 that have a combined total community economic impact that is more than \$3 million higher than the estimated economic impact of the 24 events booked in FY15/16. Travel Salem staff works out several years in advance to recruit and secure large scale events. The question was posed if Travel Salem focuses on events that project high attendance; Morris explained that that the number of event attendees doesn't equate to high estimated economic impact, that a smaller event over a longer duration that draws a broader geographic region would could have higher economic impact than a larger, shorter

event due to the number of hotel nights and meals. Morris shared that Travel Salem pursues a variety of events from religious conferences to sports tournaments regardless of size. A more in depth review of Travel Salem's 4<sup>th</sup> quarter report can be found online at:

#### **Legislative Update**

October 4, 2016

**BACKGROUND**: Your business expertise is requested to shape the legislative discussions and make specific recommendations to the Marion County Board of Commissioners in support of the priority areas in economic development.

This guide is to provide context and a starting point for discussions of what the Marion County Board of Commissioners are reviewing at the state and federal levels. This document is certainly not meant to be all encompassing, but rather a document to springboard lively discussions on proposed or necessary legislation and make official recommendations to the Board of Commissioners for review or action.

**UPDATE:** This November, a series of Oregon ballot measures are aimed at raiding current economic development dollars available in the state. These measures would limit the budgets of economic development entities around the states and in Marion County. There is a potential for significant funding loss to Marion County's and the coalition of economic development partners, if Measures 96 and 98 are approved. In combination, the potential loss of economic development funding, the potential increase of corporate taxes for large scale operations and the recent increase of the minimum wage are creating a narrative of an unfavorable business environment.

### Additional Project/Policy Items

#### **Detroit Lake Water Levels**

Detroit Lake, for the second straight summer, experienced extremely low water levels which forces boats out of the water and severely impacts the local Canyon economy. CFM worked with Ed Flick to determine the three following possible ways to address the low-water levels, and briefed the County on the feasibility of each.

- 1. Marina Extension: Two marina extensions may address the issue of keeping boats in the water, which seems to be the most likely short term mitigation that would be successful. CFM notified the County that there may be some local, state and federal funding opportunities available to help pay for a marina extension.
- 2. Full Debriefing from the Corps, Long Range Planning CFM advised that the Army Corps of engineers be brought in to have a broader discussion of their water management strategies and determine what options are available.
- 3. Hazard Mitigation Plan Some of the smaller cities in the Canyon are not currently included in the Hazard Mitigation Plan. Ed Flick indicated he would explore the possibility of adding those cities to the plan and how that could allow for additional grant funding opportunities for future flood and drought emergency declarations.

In July, CFM accompanied Congressman Schrader and his staff, Commissioners Cameron and Brentano and Governor Kate Brown's economic development staff on a day-long tour of the Canyon. While the primary purpose of the day was to explore solutions to Detroit Lake's low water levels, attendees also toured other communities and business in the Canyon to learn about their priorities and concerns.

The day culminated in a community meeting in Gates to explore solutions to the lake's low water levels and stress resiliency moving forward. The Army Corps of Engineers, together with Commissioner Cameron and Congressman Schrader, provided the community with a helpful understanding of the lake's water management process and received feedback on community and stakeholder concerns.

#### Water Infrastructure in the Canyon

CFM coordinated with Sam Goldstein in USDA's Portland office to schedule a meeting with County Commissioners and staff regarding the water and sewer infrastructure in the North Santiam communities and the steps necessary for USDA grants.

County staff effectively briefed Sam on the needs in the region, as well as the feasibility study currently underway. It was also great to hear Sam speak more to the availability of grants, something that DC staff hesitated to discuss.

The next step will be to meet with the USFS to see if they can help pay for some of the water improvements. CFM and the County will reevaluate in early fall and reach out to USFS at that time.
