12:35-12:50	Zero Suicide Updates (Cydney)	<p>Suicide prevention training internally for all staff at 4 different levels depending on the staff's position. A training matrix for staff has been finalized. Caring contacts training for staff, it is a reach out, a hopeful message. Working on a post-vention protocol for unexpected deaths in families of staff, or a co-worker or an individual in service.</p> <p>Developing a suicide fatality work group with a data tracking worksheet. 2018 data shows an increase of suicides and initial 2019 data shows a decrease in youth suicide.</p> <p>Applying for a SAMSA grant; very competitive and most likely applying for a Garret Lee Smith grant.</p>
ADDED IN	Coronavirus Update(Katrina and Dr. Cireno)	<p>HHS has set up an operations center in Abiqua Creek conference room; currently having daily phone calls and communications with community partners. HHS has also set up a phone line to address community questions.</p> <p>There have been 3 cases reported in Oregon, but reports, and data are changing rapidly from day to day.</p> <p>HHS is having many media inquiries, Dr. Cireno will be speaking with the media today.</p> <p>Risk mitigation is very important; wash your hands frequently, stay home if you are sick, avoid those who are coughing and sneezing, do not touch your face, keep social distance from people, if you are high risk stay</p>
