11:30-11:45	By Way of Introduction-Talk Around Town (All)	This discussion covered: the value that government begins locally in Marion County; there is important work being done at the county level, such as disease control, community awareness, prevention; people are looking for a local connection; many Western Oregon University students go into local government; changed happen when there is a connection between community and local government; there are discounted cultural events around the community to offer hope and inspiration; the community needs to be aware of all the services Marion County Health & Human Services (MCHHS) offers; the community is experiencing high rates of individuals with extreme mental health challenges; NORTHWEST Human Services (NWHS) is expanding their services and the size of their clinic in West Salem and has just become a member of the National Suicide Lifeline Network; Salem Health is working to collaborate with community partners; there are many agencies and individuals working hard to support individuals with co-occurring mental health and drug and alcohol addictions, get healthy and live healthy lives; the Law Enforcement Assisted Diversion (LEAD) program between MCHHS and the City of Salem Police Department has additional grant funding, the homeless camp in downtown Salem will be asked to leave due to health concerns, there is a new partnership including EMT's, Falck Ambulance, local law enforcement and staff from the Psychiatric Crisis, who will provide outreach services for individuals with health issues, that may otherwise end up at the emergency room; MCHHS Public Health program is
