- Pam Heilman gave an over view of disaster preparedness using examples of they different types of disasters that could arise in Marion County.
- (refer to the yellow handout) Marybeth gave an overview of the current county disaster plan and the Behavioral Health "Strike Team". The "Strike Team" is a select group of people who are first responders and will be the persons responsible for organizing everything in the case of a natural disaster. With Marion County, all employees will report and would be assigned to

work according to need at the time of the disaster. The first priority is the population, people will need to be triaged, have assessments and possibly psychiatric medical care. Marybeth recommends that all IDS agencies consider joining Marion County in disaster planning and would like to see them involved in some of the disaster planning exercises. - There are trainings available in January that agencies can attend. Dick will send the information to Ron and Ron will forward it to the agencies.
