12:20- 12:4	10 Cary	Survey went out to Primary Care clinics with/behaviorists. Survey respondents from YCCO & WVCH. 8 questions total. Feedback was quite positive.
12:40-1:00	p All	Clinical Sup's – Behaviorists expectations discussed regarding sharing of clinical records/documentation. Communication needed between PCP's / behaviorists and outpatient mental health provider, especially in high risk and meds area. Discussion around intake and discharge documentation and where documents go once submitted. Capacity Pilot – 60 openings in April; 96% filled. Cancellations are offered back into system, however they are hard to fill because of quick turn time. ER utilization – report to be modified due to decrease in ER utilization. Outcome Rating System – Clinician and agency overall ratings can be captured. Moving forward with implementation. Will collaborate with programs using ORS (EASA). Details still need to be addressed.
