 Capacity Capacity Intake Appointments/Google Calendar Managing Impact of New Enrollments Co-location LOC 		11:10-Noon	Cary	Google calendar averaged 17 appointments a week in the system when initiated; now that number has dropped to 10. 79% access within 14 day time frame; 5% decline overall. In April the IDS reported 140 available appointments in the system. In May that number dropped to 90. Agency hiring may alleviate some of the access problems. There has been feedback from some intake coordinators that they are not receiving enough information from the behaviorists to begin the intake process. Marion County CAPS urges agencies to participate in the Google calendar system as this is our commitment to the BCN. Members able to obtain initial appointments but cannot receive ongoing treatment at times. No shows continue to be a chronic issue. Discussed disconnect between reporting of available appointment and actual weekly capacity. Agency specific referral processes discussed and interest in simplification and consistency to expedite referrals and improve sense of coordination.

Seems to be consistent issue around information between PCP's and Behaviorists and where that information is located. It was suggested that there be contact between Behaviorist/clinics to determine point of contact at each PCP clinic. More requests from PCP regarding co-location. Discussion needed around models/placements and whether we are serving the right group of members at co-locations based on levels of care. This is necessary for service, intensity and need of member. Cary will take issue to BCN and maybe WVCH clinical advisory panel.
