Review and Discussion: AMH/PHD project related to reducing opioid deaths in Oregon – AMH workgroup interim report attached

- The majority of the deaths were people age 22-54 in Oregon
 - o Dramatic increase in access to programs and prescriptions
 - o Prescription overdose increased over 900% since 1999
 - o Many people are being prescribed opioids for pain in the ER
- ➤ Looking to create a statewide awareness Is this something that LADPC would want to take on as a project?
 - o Pilot project of usefulness of contacting the PCP to make them aware that there client is being prescribed opioid medication.
 - o Making Buprenorphine more available
 - o It is harder to misuses and is a safer treatment
 - o Not in the OHP formulary. It is more expensive
 - There is an exception process to get it
- ➤ 2 Levels of detox in Oregon
 - o Social non medical and Medical Detox or Enhanced detox
 - The state is going to support more medical detox situations
 - o State is putting out an RFP for Enhanced Medical detox
 - o Bridgeway is looking to apply to be a medical detox facility and would like the committee's support for the RFP such as a letter of recommendation/support
 - o Scott will email the RFP before the letter is written
