#### I. Announcements and Introductions

- Marion County-Roberto Camarillo has transferred to the adolescent program.
   Since his transfer his family group has increased to about 20. Methadone is going to be focusing client mentors to help prevent relapse.
- O Polk County is being remodeled. Polk County in West Salem has opened. They have 5 CADC's, 2 Mental Health Therapists. They will be opening children's mental health hopefully in April. They will be starting to do electronic medical records in April. They will begin there services for the Jail next week.
- Bridgeway is working on shifting from social detox to enhanced medical detox. They have added a part time adolescent counselor. They have received a grant from the sheriff's office to provide mentoring services for those in prison services.
- Scott announced that on March 16<sup>th</sup> the BCN will be hosting David Jefferson.
   He will be talking about Chemical Dependency and COD for Adolescents.
   Also a reminder that SAMSA has free videos and for Family education.
- Scott also let people know that OHSU with the BCN is sponsoring a SBIRT training. They will be held on Feb 21 and March 14 at the Roth's conference center in West Salem.
- Cary announced that Linda Hammond the AMH interim director will be coming down to view several agencies services.

### II. Admissions/Discharge Outcome Data – Everyone

- o Scott handed out data from July 2010 to 2011.
- o There needs to be an employment class
  - o People are having a hard time getting jobs because of felonies, many jobs are graveyard which is not a good fit. Many applications are

online and there are a large number of people that do not have online access.

- o Goodwill will help with resumes and job coaching. They have a free GED class
- o Chemeketa is starting a recovering mentor program
- There seems to be better discharge outcomes with OHP than with SE66
   Funding
  - o Access to mental health services from uninsured is a big problem

# III. System Expectations for Treatment Completions– Everyone

- o We are going to look at the previous numbers and that will become the baseline for the treatment completions.
- O Using the data as a baseline we need to think about what percentage of change we would like to hope for in the next fiscal year.

### IV. Clinical Practice- Scott/Everyone

- o Funding extension requests should go through supervisors first
- o Clear Paths has a 4 week wait for assessments
- MCHD is out till mid March They are looking at bringing in a temp just for assessments. Methadone counselors are going to be doing 1 assessment a week.
- Polk has no wait list. They are doing open access and there No Show rate went down. If clients have appointments and they No Show twice they can only get an assessment through open access.
- o BRS is 2 weeks out and are working on expanding to do more. They are going to have a contractor do immediate intakes on Thurs.
