### II. 2011 Legislation-Planning for the future

Coordinated Care Organizations HB 3650 - Dean/All

- 4 Workgroups
  - What is a CCO
  - What's included in a global budget
  - How to measure the CCO
  - Medicare and Medicaid
- Not clear on the organizational criteria. Might need to be a non-profit
- Looking at a Marion-Polk CCO. Yamhill is still in question.
- Utilization is going to be the Key. Use resources better than the way we are using them. Looking at Payment reform, how we pay for services. Primary care is in the drivers seat

Fee Schedules and Costs

- Going to take a while to create all the incentives and have the shared savings
- Partnering with the hospital and other specialists
- There is an integration for mental health and substance abuse
- Working on a registry that would be an extension of the claims process. Working on changing the limits on narcotics. Can lock people to 1 prescriber and 1 pharmacy.

Bills that passed – HB 2103, HB 2104, HB 2650, SB 238

- HB2103 Makes OHP responsible to pay for drug treatment for a mandated DUII treatment for OHP eligible offenders
- HB2104 Replenishing the intoxicated driving fund. They want 2/3 to go to treatment and 1/3 for interlock devices
- HB2650 Fixes 2442 that exempted a lot of people from working in the field. This bill changes the disqualification exceptions
- HB3110 evidence based model for prevention
- SB238 requires a task force

# IV. MPCHP/Indigent Panel

LADPC Senior Services Sub-Committee- Specialty service to be advertised

- Seniors are currently being underserved. LADPC is working on a survey that could be distributed to PCP's and all A & D providers to see what the need for services is.
- Senior's are being defined as 55 and older
- Bridgeway is working on a pilot group

# V. SE66 Contract 2011-2012

- AMH is going to a performance based contract
  - The number to serve in the indigent program is 641 across Marion County. This only includes people that are in the program for greater than 30 days before discharge
  - SE66 fund money will be tracked by the discharge payer code of 65.
  - If the target number is not served then the money will be taken back in \$1200 increments for each of the number of people not served.

# VI. Collaboration with Corrections

Funding for Drug Court-Changes

- Working on some drug court money through some grants
- High number of people from corrections being sent to out of panel providers and not referred in panel
- Working on trying to make it clearer where to send corrections people
