I. Announcements and Introductions

- Donna Waller from Easter Seals announced she will be acting as the interim director.
- Collaboration with Child Welfare
- They have received a mini Casey Grant and will be using it to serve 10 families with children 0-5 years of age
 - Focusing on trauma informed care
 - They will be using the circle of security parenting model
 - Please let Cary know if you have any staff trained in this model
 - The new DSM will have a place for a diagnosis around trauma
 - Youth & Family Workgroup through the BCN
 - This group meets the 2nd Monday from 9-11:30

III. Health Care Transformation –All

Legislative Report

- Bill 1580 – CCO
 - Dash 9 amendments
 - Strengthens the advisory committee
 - Addresses governing boards
 - Went without the dash 7 torte reform
- Willamette Valley Health Authority is meeting with the hospital
 - Working to make it community based
 - There is disagreement around money structure

Local Impact – FMG Report

- Funding issue is based on the enrollment growth which was predicted at 1% a month
 - Growth didn't happen
 - There are less reserves since we have been relying on them
 - Cuts could be about 6% lower
 - We are unsure at what point the cuts will affect providers

IV. Polk – Cross County Services

- They have 3 Mental Health Therapist for adults
- 5.5 CADC's for adolescents and adults
- Services for Children will be in Phase 2, May
- They have some prescriber time
 - 1 Day in Polk-West Salem
- They have a bilingual provider
- There is not a sign yet, but there is a temporary banner
- Moving to electronic health records in April
- Polk county offers both counseling and med management services at the West Salem location.
- They have a Modified Open Access (50 options per week) for Mental Health and Addictions
- Hours on Friday have changed to 8:30-5
- All agencies are welcome to go to the clinic for a tour
- There will be an evaluation of the number of Polk County residents currently in service at ABH, they will be informed about new location in W. Salem.
- Intake coordinators are starting to refer to Polk County West Salem based on a client's place of residence.

V. Reports

Monthly IDS Reports – Dwight

- 2011 incentives should be finished next month
 - Working on creating the new baseline for engagement

- The monthly incentive for access was received from May-Dec
- Administrative Performance
 - Take a look at the following places and see if your agency is falling into these issues
 - Diagnosis inconsistency
 - Authorization missing
 - No longer eligible
- Access for January was 81%
- LOC – Agencies will now be able to claim clients immediately
 - There will be a “Primary Authorization” option in CIM
 - Assessment plus 2 visits to complete the LOC
 - Thirty (30) day auth period to allow clinicians to more accurately identify the appropriate LOC.
 - At the end of the Primary Authorization period or sooner, agencies will enter an extension authorization in CIM. This extension will not change the start date and the cost to date will follow the new LOC authorization
 - Anticipate an implementation date of April 1st.
- Data Mining
 - Will bring data mining reports to meetings on a quarterly basis

VI. Prescriber Issues

- Valley has had some prescribers give notice
 - 1 Special Services prescriber has resigned effective March 1st
 - They have hired a new prescriber who is going to be taking the special services
 - Tom Breyer and Gayle Webbie leaving Valley
 - They mostly saw kids for medication only
- Valley reports effort to transfer members back to PCP as challenging.
- Medication 2nd authorizations will likely be terminated.
 - Kathleen has a list of 2nd authorizations
- NWHS offered positive feedback in regard to their model for medication consultation
- VMH is considering a similar model for access for new clients
- Dr. Marcin in conjunction with the BCN is holding monthly seminars for medication consultation and for Children prescribers

VII. AMH Variance

- The BCN no longer requires agencies to use their credentialing adjunct provider forms for QMHA's & QMHP's Given that AMH will be issuing the variance.
- If approved, the State will provide the variance which will be good for one year.

- The template provided to IDS providers to request the variance should be sent to CAPS, who will seek CMHP approval and forward to AMH for final approval.
- Cary will check on the completion process. Follow up - AMH staff indicate the process should be completed by AMH within 30 days of receiving the request
