## **Approval of Meeting Minutes:**

#### **Review and Discussion:**

- Barrier Busters-Coordination of Efforts
- Scheduling work group sessions to propose increased residential capacity
- Presentation to the Board of Commissioners-developing a work group and presentation
- ❖ Judge Abernathy gave a brief overview and background of the Barrier Busters group and what their priorities and goals are. They officially started in May 2006 when there were 1200 abuse and neglect cases in Marion County, many of them due to methamphetamines. Judge Abernathy is seeing meth-affected families in her court at least twice a week and 1/3 of the children are under the age of three. In her experience, the longer the children are separated from their moms the harder it is for them to form a bonding relationship thus making it hard for the children to bond with people when they get older. Her goal is to get the moms help and to return the children to their mothers as soon as possible. Judge Abernathy would like to see "Her Place" residential capacity expanded as they have a solid track record with positive outcomes and the residential milieu allows her to return the children more quickly.
- ❖ The Barrier Busters group would like the support of the Local Alcohol and Drug Planning Committee in expanding residential capacity.

- ❖ Judge Abernathy believes that community members would pull together to purchase a house and cover some of the start up expenses. The primary problem is sustainable operating resources.
- ❖ Based on the work of the committee with the stabilization house proposal, Trish stated that it would cost approximately \$300,000 per year to maintain this type of housing.
- ❖ Judge Abernathy would like to participate with an LADPC subcommittee on this project.
- ❖ Mark proposed the formation of a subcommittee to look at the possibilities and costs of development and long-term sustainability.
- \* Ray seconded the subcommittee proposal and suggested that the committee bring back information to the LADPC meetings in May and June.
- ❖ People that volunteered to be on the sub committee included: Trish, Mark, Sue, Bonnie, Jay, Rod and Ray.
