# PURSUANT TO THE EAST SALEM SERVICE DISTRICT ORDINANCE #1174, the District hereby permits the requested improvements:

The structure shall be constructed or modified in accordance with East Salem Service District (ESSD) standards and other requirements as shown below. A copy of the permit shall be posted on-site during the work. The work authorized under this permit must be completed <u>during dry ditch conditions</u>. If work is not completed within this time frame, this permit shall become void. The structure shall be installed and maintained as approved. The structure shall not block or restrict storm water passage; see Ordinance #1174.

## Follow STANDARDS & SPECIAL PROVISIONS below.

No construction shall commence prior to approval from ESSD through Marion County Public Works. All materials and construction will be approved on a case-by-case basis. All materials shall be resistant to the effects of buoyancy, weather, and erosion. All structures shall not diminish the ability of the drainage system to pass/convey storm water or reduce the cross-sectional area of the ditch. The proposed structure shall be resistant to the undermining and erosive effect of storm water flows. All area within the public easement disturbed by the project shall be restored to the same or better condition. Erosion and sediment control must be used as planned and final stabilization approved by Marion County.

PLEASE NOTE: 48 HOURS PRIOR TO START OF WORK AND 24 HOURS PRIOR TO POURING CONCRETE, CALL MARION COUNTY DISPATCH AT 503-588-5304 FOR FORMS INSPECTION. PERMIT MUST BE IN PLACE BEFORE CALLING. OTHER LOCAL, STATE AND FEDERAL PERMITS MAY BE REQUIRED. IT IS YOUR RESPONSIBILITY TO OBTAIN THEM.
