Please read the following information carefully before submitting your application. Incomplete applications will not be accepted!

Cadet Application, Interview & Selection

Cadet applications must be submitted by October 15th to be considered for the next Cadet Academy. Please note: If your application is submitted after the due date (and accepted), we will still let you come on as a cadet, but you will be required to attend the Cadet Academy the following year.

Please check your application and make sure it is complete. A complete application is one that has all questions answered (or filled in with N/A if it does not apply to the applicant). Incomplete applications or applications that are not signed will not be accepted and the applicant will not move forward in the selection process.

Please make sure you have the Personal Inquiry Waiver page signed and notarized, and return it with your application. Applications without a signed Personal Inquiry Waiver will be considered incomplete and will not be accepted.

Interviews are scheduled throughout the year. You will be notified of the date and time of your interview.

If you are selected to become a recruit cadet, you are required to attend the Marion County Sheriff's Office Cadet Academy. 100% attendance at the academy is required. The only excused absence from the Cadet Academy will be for taking a college entrance exam (SAT, ACT, etc.). If you are unable to attend the Cadet Academy on ALL of the scheduled dates for any reason besides taking a college entrance exam, you must notify a Cadet Advisor and obtain permission. There are no exceptions to the attendance requirement.

Cadet Academy Schedule

Every Saturday beginning mid-January and ending early March. A graduation ceremony will conclude the Academy.

All recruit cadets are also required to attend the Cadet orientation meeting with at least one of their parents/guardians in December (date/location are to be announced).
