PRESENTATION

1. Travel Salem quarterly report. –Brian Moreland and Angie Onyewuchi, President and Chief Executive Officer, Travel Salem

Summary of presentation:

Brian Moreland:

- Travel Salem has a contract with Marion County effective from 2018 through 2023; and
- The contract's purpose is to help pursue economic development in the tourism sector.

Angie Onyewuchi, President and Chief Executive Officer, Travel Salem:

- Travel Salem's quarterly report aligns with the five-year strategic plan:
- The strategic plan has the following four core areas of focus:
 - o Destination experience;
 - o Destination development;
 - o Destination marketing; and
 - o Organization optimization.
- There are nine key performance measurements that are tracked:
 - o An achievement target is established at the beginning of the fiscal year; and
 - The target is compared to the prior fiscal year goals.
- The following are some of Travel Salem's recent marketing and communications efforts:

- Collaborating with Amtrak, to develop a new website page that will be focused on the region;
- O Developing a cultural heritage work plan;
- Maintaining social media blogs:
 - Several of the images are provided by public members that help to promote communities;
 - Video content is produced in-house;
 - Featured destinations on the blog page have included some of the following:
 - The Oregon Garden;
 - The Willamette River Water Trail;
 - Keizer Rapids Park;
 - Coria Estates;
 - Salem Community Markets;
 - The Silverton Farmers Market;
 - The Willamette Mission State Park; and
 - The Silver Falls State Park.
- o The Travel Salem website has been redesigned:
 - The new design has received positive feedback;
 - The content is engaging visitors; and
 - Browsers can quickly navigate the site.
- To increase business bookings in the area, Travel Salem contracted with Small Market Meetings for a year-long campaign that includes a familiarization tour for meeting planners;
- Travel Salem has attended trade shows in other states to recruit business to local communities:
 - o They have met with 36 planners and 31 sports planners.
- Travel Salem partnered with the Willamette Valley Visitors Association to assist in bringing the finale of "Top Chef" to the Willamette Valley Vineyards:
 - o An estimated 2.5 million people watched the finale; and
 - o The event helped to promote multiple locations around the county.
- "Forbes" magazine covered the Silver Falls State Park which is one of the top attractions in the state;
- "Portland Monthly" magazine wrote an article detailing ten Oregon museums to visit outside of the City of Portland including the Mount Angel Abbey and the Gordon House;
- The following events received coverage on Travel Salem's social media page:
 - o The reopening of Enchanted Forest;
 - o Marion and Gatch Falls;
 - o Marion Farm Loop which features a variety of local farms; and
 - o Hispanic Heritage Month.
- Video content is critical for promoting a destination;
- Travel Salem secured a three-year contract with Ironman 70.3 Oregon:

- o Approximately 2,250 athletes competed in 2021;
- o The 2021 event produced over \$10 million in economic impact; and
- Approximately 3,400 athletes have registered for the next competition which is scheduled for July 10, 2022.
- Travel Salem is responsible for an estimated \$22 million in economic impact from conventions and sports businesses that they recruited into the market during the first quarter;
- Travel Salem has booked approximately \$2 million in future convention business, and an estimated \$24 million in future sports business;
- Following are areas that Travel Salem is currently working on:
 - Workforce challenges:
 - Tourism was the hardest hit sector of the economy during the COVID-19 pandemic; and
 - Monitoring the Omicron variant of the virus continues:
 - Consumers are ready to travel again.
 - o Building a service brand to gain repeat customers:
 - The tourism sector of the local economy is known for its customized service.
 - o Leveraging the new visitor dynamic:
 - Visitors can work remotely from anywhere;
 - Visitors working remotely often extend their vacation;
 - Broadband access in rural communities is critical; and
 - A group of Salem hoteliers are assessing the possibility for additional guests' fees:
 - The group has invested \$1 million that can be utilized for promotions and advertising in the area.
 - Fly Salem is an effort to recruit commercial air service to the Salem Airport:
 - This may increase employment opportunities; and
 - Individuals may be able to fly out of the Salem Airport to other destinations around the world.
 - Travel Salem oversees the marketing dollars that promote Region One which entails the following counties:
 - Marion;
 - Polk; and
 - Yamhill.
 - Travel Salem contracted with a global marketing company to perform strategic planning for the region; and
 - Travel Salem is working to determine the best course for utilizing the funds that will promote the region.
 - The company has purchased a building that will become the new Travel Salem headquarters:
 - The building space will be utilized to host events; and
 - Drive-up visitor information may be an option.

- o A staff liaison is working with the cultural heritage sector; and
- The company is hiring a destination development specialist that will focus primarily on Marion County.

- Travel Salem's quarterly report helps the community to understand how their dollars are being invested;
- The Marion County Economic Development team started the Community Prosperity Initiative with each of the cities in Marion County:
 - Some of the cities have combined their incoming funds from the initiative to promote tourism in their area; and
 - o The Marion Farm Loop also participates in area events.
- Local newspapers have been promoting activities within the Santiam Canyon;
- The county continues to support the Oregon Garden:
 - The Little Leaf Cafe located within the garden provides dine-in and catering services; and
 - o It was suggested that Travel Salem partner with the Oregon Garden to find ways to promote small businesses located on the garden grounds.
- Promotion for smaller towns located outside of the City of Salem is imperative:
 - o The commissioners would like to see the county's small towns integrated into the tourism planning; and
 - o Small communities can benefit economically from tourism.
- The county is competing for tourism dollars with destinations all over the world:
 - O Visibility, profile, and allure are important for attracting tourism;
 - o Tourists come to this region to experience the county's wineries and the recreation:
 - These activities exist in the rural communities; and
 - Travel Salem is promoting activities in the rural communities as a part of an entertainment package for individuals visiting the City of Salem area.
- The commissioners requested more information for promoting rural communities in a future report; and
- Travel Salem's Facebook and Instagram pages show the diversity of the work being done.

5. Consider approval of Amendment #3 to the Engineering and Related Services Contract with DOWL, LLC to add \$315,737 for a new contract total of \$948,822 to provide construction contract administration and construction engineering and inspection services for the River Road South: Willamette River, Independence, Bridge Project through June 30, 2022.

Summary of presentation:

- The bridge is located south of the City of Salem and near the City of Independence:
 - The bridge spans across the Willamette River between Marion County and Polk County;
 - o The bridge is 2,290 feet in length; and
 - o It is one of the largest bridges in the county.
- The project scope addresses the scour concerns that were specified in a bridge inspection report:
 - o It focuses on the scour concerns for pier three, and piers seven through ten.
- Additional project scope related to the scour repairs includes the following:
 - o Temporary traffic control;
 - o Erosion control;
 - Install temporary work bridges;
 - o Remove two piers;
 - o Install cofferdams to remove water in the work area; and
 - Restore the area to pre-construction conditions by planting native vegetation.
- DOWL, LLC performed the detailed design work for the project;
- The company has inspectors that specialize in this type of work;
- Public Works would like DOWL, LLC to oversee the construction phase of the project;
- The amendment scope includes providing the following services:
 - o Professional of Record (POR) construction engineering; and
 - o Construction inspection.
- A large percentage of the amendment dollars will be utilized for an on-site inspector that will verify that the work is being performed correctly:
- The following tasks are included in the amendment:
 - o Construction inspection;
 - o Construction submittal review;
 - o Design changes if required;

- o Environmental inspections;
- o Permit compliance monitoring; and
- o Provide "As Constructed" plans and bridge data that can be submitted to the Oregon Department of Transportation (ODOT).
- Construction for the project will occur in 2022 through 2023;
- The prior contract total for design was \$633,085:
 - Amendment #3 adds an estimated \$315,737 for construction services; and
 - The new contract total is estimated to be \$948,822.
- The grant project is funded by the state:
 - The state is funding approximately 89.73 percent of the project expense which is estimated to be \$2,850,800; and
 - o The county is responsible for any project overages over \$2,850,800.

- The state has modified the way they calculate load ratings for bridges:
 - o A significant number of Marion County bridges recently had load ratings attached to them:
 - ODOT has a contract with a consultant that requires bridges to be load rated due to federal regulations;
 - The load ratings restrict access to some bridges;
 - Public Works staff is reviewing the restrictions and performing extra analysis, when possible, in an effort to find a solution; and
 - The changes have significantly impacted farmers and rural emergency service providers.
- The county is committed to keeping bridges safe;
- Staff maintains a list detailing needed bridge repairs and available funding;
- There may be only one analysis performed and one load rating submitted that can potentially encompass multiple bridges;
- Closures impact the daily lives of individuals utilizing the bridges; and
- Public Works staff responded quickly to address load rate restrictions especially for a bridge closure that could potentially landlock local farmers during the harvest season.

MOTION: Commissioner Willis moved to approve Amendment #3 to the Engineering and Related Services Contract with DOWL, LLC to add \$315,737 for a new contract total of \$948,822 to provide construction contract administration and construction engineering and inspection services for the River Road South: Willamette River, Independence, Bridge Project through June 30, 2022. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.

6. Consider approval of Amendment #1 to the Contract for Services with the Mid-Willamette Valley Community Action Agency to add \$70,000 for a new contract total of \$270,000 to provide support services to community corrections clients through the DeMuniz Resource Center through June 30, 2023. —Commander Kevin Karvandi

Summary of presentation:

- The funding source for the contract amendment is through the Criminal Justice Commission (CJC) Justice Reinvestment Grant agreement that was approved at a board session meeting held on January 26, 2022;
- The original contract with the Mid-Willamette Valley Community Action Agency (MWVCAA) was effective July 1, 2021;
- The contract amendment aligns with the Justice Reinvestment approved program budget;
- The MWVCAA is a local nonprofit that provides numerous programs, including the DeMuniz Resource Center:
 - o The organization has been in business since 2011;
 - The agency has been the home for Marion County's Transition Center since 2013;
 and
 - o They have been excellent partners for the county.
- The DeMuniz Resource Center is one of the county's justice reinvestment programs:
 - The center is a one stop center designed to improve access to resources by providing a variety of support assistance to ensure justice involved individuals can successfully transition to the community;
 - The target population includes the following:
 - Pre-trial clients:
 - Adults in custody at the transition center; and
 - Justice involved individuals on supervision with the Sheriff's Office.
 - Assistance includes the following:
 - Navigator one-on-one coaching for success planning to address barriers to successful re-entry;
 - Coaching on how to navigate and access local resources;
 - Referrals for some of the following:
 - Employment;
 - Education:
 - Obtaining identification;
 - Housing; and
 - Transportation.
 - In-house classes and workshops including some of the following:
 - Cognitive skills;
 - Motivation clinics:
 - Legal clinics;
 - Employment assistance;
 - Parenting classes; and

- Oregon Health Plan (OHP) sign-up clinics.
- The funding for the contract supports the staffing of four full time navigators, including one bilingual housing navigator.

- The budget for all programs was approved by the Public Safety Coordinating Council;
- The increase is due to the Sheriff's Office not knowing how much funding was going to be received from the Justice Reinvestment when the original contract was approved;
- The funding keeps the program and services continuing;
- The board approved the Justice Reinvestment Grant application on January 26, 2022;
- Supplemental funding is required for the program:
 - O Justice Reinvestment has never completely funded the following:
 - The four navigator positions;
 - A director's position; and
 - An office manager.
- The commissioners requested an overview of a detailed budget for the DeMuniz Resource Center at a future Management Update meeting:
 - The annual budget for the center is estimated to be between \$300,000 and \$400,000;
 - More staff was added in prior years;
 - More information related to the partnerships, all the programs, and the community agencies was requested;
 - O The added funding requested in this contract only covers a portion of what is needed for the program; and
 - Each program may require several funding streams to operate.
- The program helps individuals to transition successfully following incarceration:
 - o It is important that individuals transitioning do not commit crimes in the future.
- Many communities are currently struggling with theft and vandalism;
- Decisions made by the state have impacted the county; and
- The programs help to keep communities safe.

MOTION: Commissioner Cameron moved to approve Amendment #1 to the Contract for Services with the Mid-Willamette Valley Community Action Agency to add \$70,000 for a new contract total of \$270,000 to provide support services to community corrections clients through the DeMuniz Resource Center through June 30, 2023. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.

- 7. Consider approval of the Contract for Services with Pathfinder of Oregon, dba, The Pathfinder Network in the amount of \$259,752 to provide mentoring assistance for justice involved individuals participating in the Peer Support Program through June 30, 2023.
- -Commander Kevin Karvandi, Marion County Sheriff's Office and Leticia Longoria-Navarro, Executive Director, The Pathfinder Network

Summary of presentation:

Commander Kevin Karvandi:

- Part of the funding source for the contract is provided by the Criminal Justice Commission's Justice Reinvestment Grant agreement;
- The contract supports the launch of the new Justice Reinvestment peer mentor program that is titled the Resilience and Recovery Project:
 - The project is a peer mentor program for justice involved individuals.
- The program goals include some of the following:
 - Utilize peer mentors to increase access and engagement of the following in underserved communities:
 - Programs;
 - Services; and
 - Resources.
 - o The successful reentry of an individual into the community; and
 - The completion of supervision.
- Increasing access to evidence-based programs and services will help the county to accomplish their justice reinvestment goals:
 - o Reduce recidivism; and
 - o Reduce prison utilization.
- The target population of the project is high and medium risk individuals on supervision with the Sheriff's Office:
 - o The population includes both males and females.
- Stationing peer mentors within the public safety building provides for the following:
 - o A high level of customer service:
 - o Face to face referrals;
 - o Easy access for both deputies and clients; and
 - o Enhancement of collaboration and communication for case planning.
- Peer mentors have lived experience that helps them engage participants.

Leticia Longoria-Navarro:

- The non-profit Pathfinder Network has been in business for 29 years;
- The company was founded to provide tools and support for individuals impacted by the justice system;
- The Pathfinder Network works towards the following:
 - o Ensuring public safety;
 - o Helping individuals with successful reentry; and

- o Helping individuals obtain successful completion of community supervision:
- The Pathfinder Network, which is located in 11 of the 14 Oregon prisons, provides some of the following services:
 - o Parenting and cognitive behavioral programming;
 - o Peer support services; and
 - o Basic needs assistance.
- The program providers have lived experience with the criminal justice system and have been through the challenges of parole and probation;
- A variety of different approaches are utilized:
 - O Supporting individuals with peer mentoring that is driven by the following:
 - Evidence based practices;
 - Client centered practices;
 - Group based intervention;
 - Cognitive behavioral approaches;
 - Drop-in support for individuals with an immediate need; and
 - Wrap-around supports focusing on the following:
 - Individual strengths;
 - Individual risk factors.
- Peer mentors will have a caseload of individuals that they will work with; and
- The programs change the outcomes for individuals impacted by the justice system:
 - o Removes barriers; and
 - o Provides needed support.

- The contract funds the following:
 - o Two full time peer mentors:
 - One of the mentors will be bilingual.
 - The immediate needs of a participant that cannot be provided by other providers in a timely manner.
- The balance of a female mentor and a male mentor helps to ensure that the relationships are a good fit;
- Mentors will be available during business hours and is based on capacity:
 - o They may be available after hours for emergencies.
- Mentors are an important part of the Sheriff's Office reentry programs:
 - The Student Opportunity for Achieving Results (SOAR) program;
 - o Prison diversion programs;
 - o The Family Sentencing Alternative Pilot Program (FSAPP); and
 - o The Link Up program.
- In addition to working out of the public safety building peer mentors will also work with individuals at other community locations;
- Each peer mentor will have a caseload of 15 to 18 individuals; and
- The contract ending term date is June 30, 2023.

MOTION: Commissioner Willis moved to approve the Contract for Services with Pathfinder of Oregon, dba, The Pathfinder Network in the amount of \$259,752 to provide mentoring assistance for justice involved individuals participating in the Peer Support Program through June 30, 2023. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.
