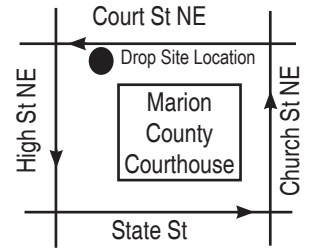

City of Aurora**

Referred to the People by the City Council

Amends City Charter Provisions On Municipal Court

Question: Shall the city amend the city charter's municipal court provisions by requiring the court to be established by city ordinance?

Summary: Currently, the City Charter names the municipal judge as a city officer and requires a municipal court be established and operated in a specific manner for particular offenses and/or crimes. Adoption of this amendment eliminates the requirements found in the charter and instead places the responsibility for establishing a municipal court and specifying its powers with the City Council via ordinance.

**Measure No. 24-352
Silver Falls School District 4J**

Referred to the People by the District Board

Silver Falls School District Capital Construction and Maintenance Bond

Question: Shall Silver Falls School District No. 4J issue general obligation bonds not exceeding \$36,900,000 with citizen oversight? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of Sections 11 and 11b, Article XI of the Oregon Constitution.

Summary: If approved, this measure would provide funds for capital costs and bond issuance costs. Specifically, bond proceeds would be used to:

- Fund deferred maintenance and facility upgrade projects at each of the District's elementary schools. Examples of deferred maintenance projects include re-roofing, painting, improved plumbing and electrical, flooring replacement, and parking lot repair. Examples of facility upgrade projects include door locks, security cameras, fencing, telephone and intercom, technology infrastructure, furnishings and equipment.
- Fund the reconstruction of the Schlador Street campus into a grades 5-6 self-contained, 7-8 departmentalized school, related site improvements, furnishings and equipment. Completion of this project results in the discontinued use of Eugene Field School.
- Pay bond issuance costs.

Bonds would mature in twenty-five (25) years or less from issuance date and may be issued in one or more series. Estimated yearly property tax rate is anticipated to remain at existing levels due to expiration of outstanding bonds. Actual rate may vary depending upon interest rates, assessed value growth, and other factors. Citizen oversight committee will ensure funds are used as intended.

My second priority is to make sure transit is considered as Salem's development continues. Proper planning can make it easy for transit to supplement a development's appeal and success. Unfortunately, some of our newer developments are difficult to access by transit. The board should work with planning to see that this doesn't happen in the future.

We have heard advice to "think globally, act locally." When I was growing up, the globe's population was 3 billion. Now it's 7 billion. Good jobs in Oregon are growing fewer, while low-paying service jobs are proliferating. Perhaps the lean economic conditions we are experiencing are our new normal, where buying a new car is getting out of a middle-class family's reach. 

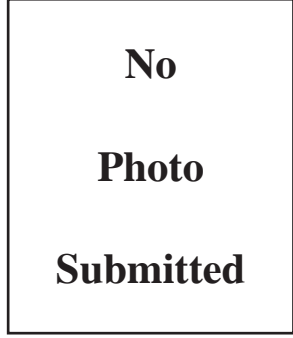

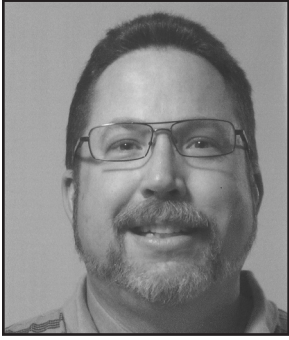
If we need to save \$500,000 why not get rid of 10 surplus \$81,000 a year teachers and bring our student teacher ratio up to 25 to 1.

City of Aurora**

Referred to the People by the City Council

Amends City Charter Provisions On Municipal Court

Question: Shall the city amend the city charter’s municipal court provisions by requiring the court to be established by city ordinance?

Summary: Currently, the City Charter names the municipal judge as a city officer and requires a municipal court be established and operated in a specific manner for particular offenses and/or crimes. Adoption of this amendment eliminates the requirements found in the charter and instead places the responsibility for establishing a municipal court and specifying its powers with the City Council via ordinance.

Explanatory Statement:

This measure would amend the Aurora City Charter by eliminating the requirement that the City have a Municipal Court. The new wording places the responsibility for establishing a Municipal Court and specifying its powers with the City Council by Ordinance. If approved, the Charter would read as follows:

Chapter III, Section 5 of the Charter of the City of Aurora.

Section 5. OTHER OFFICERS. Additional officers of the city shall be a Treasurer, a Municipal Judge (if appointed), a Recorder and such other officers as the council deems necessary. All officers of the city shall be appointed by the Mayor with the consent of the council, and shall hold their office during the pleasure of the council or until their successors are appointed and qualified. Appointed officers are subject to removal at any time by the council with or without cause. The duties of all officers not defined in this Charter may be prescribed by the council. The council may combine any two or more appointive city offices.

Explanatory Statement: (cont.)

AND

Chapter V, Section 3 of the Charter of the City of Aurora.

Section 3. MUNICIPAL JUDGE. The council by ordinance may establish a municipal court and a position of municipal judge. If so established, the municipal judge shall be the judicial officer of the city. He or she shall hold within the city a court known as the Municipal Court for the City of Aurora, Marion County, Oregon. The court shall be open for the transaction of judicial business at times specified by the council. All area within the city shall be within the territorial jurisdiction of the court. The municipal judge shall exercise jurisdiction as specified in the ordinance establishing the court for all offenses defined or authorized by the ordinances of the city. The court shall have all authority specified in the ordinance establishing the court.

Silver Falls School District Capital Construction and Maintenance Bond

Question: Shall Silver Falls School District No. 4J issue general obligation bonds not exceeding \$36,900,000 with citizen oversight? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of Sections 11 and 11b, Article XI of the Oregon Constitution.

Summary: If approved, this measure would provide funds for capital costs and bond issuance costs. Specifically, bond proceeds would be used to:

- Fund deferred maintenance and facility upgrade projects at each of the District's elementary schools. Examples of deferred maintenance projects include re-roofing, painting, improved plumbing and electrical, flooring replacement, and parking lot repair. Examples of facility upgrade projects include door locks, security cameras, fencing, telephone and intercom, technology infrastructure, furnishings and equipment.
- Fund the reconstruction of the Schlador Street campus into a grades 5-6 self-contained, 7-8 departmentalized school, related site improvements, furnishings and equipment. Completion of this project results in the discontinued use of Eugene Field School.
- Pay bond issuance costs.

Bonds would mature in twenty-five (25) years or less from issuance date and may be issued in one or more series. Estimated yearly property tax rate is anticipated to remain at existing levels due to expiration of outstanding bonds. Actual rate may vary depending upon interest rates, assessed value growth, and other factors. Citizen oversight committee will ensure funds are used as intended.

Explanatory Statement:

In September 2011, the most recent Long Range Facility Planning Committee was formed, comprised of community members from each school attendance area in the district as well as municipality, school board and school employee representatives. The group was charged with developing district-wide facility recommendations for consideration by the Silver Falls School Board and met monthly between October 2011 and May 2012. Members became familiar with recent facility studies and current conditions, safety and security needs, history of district schools, projected enrollment, anticipated instructional requirements, 21st

century educational needs and other facility related information. Facility recommendations were formed and submitted to the school board in June of 2012. After review, public input and some modifications, the recommendations were approved by the board, including the recommendation to place a bond on the May 2013 ballot.

If approved by the voters, bond proceeds would be used for completion of a variety of district-wide deferred maintenance projects and facility upgrades. Completion of these projects would allow for continued use of each school and include the following:

- Roof Replacements.
- Plumbing and Electrical Upgrades.
- Improvements to heating, ventilations systems and related controls.
- Site water collection and drainage improvements.
- Sidewalk, parking lot and playground improvements.
- Structural repairs.
- Siding improvements.
- Restroom improvements.
- Flooring repair and replacement.
- District-wide infrastructure upgrade for equal technology access in each school.
- District-wide safety and security upgrades including installation of electronic perimeter door hardware, classroom door hardware, security cameras and additional fencing.

Bond revenue would also be used for conversion of the Schlador Street (former high school) campus to a school for Silverton area students in grades 5-8. To address seismic and code compliance requirements, this conversion includes a combination of partial demolition and new construction. Completion of the Schlador Street conversion would allow for discontinued use of Eugene Field Elementary School. Mark Twain and Robert Frost Schools are expected to be used for Silverton area students in grades K-4. The grade configurations for these schools would be determined following public input and evaluation of multiple options.

The Board also intends to sell surplus property with the proceeds dedicated to funding of district-wide maintenance projects in the future.

Based upon a \$36,900,000 bond, the total estimated bond levy rate is projected to remain at the current level of approximately \$3.35 per \$1000 of assessed value for the life of the bond. The final payment on the school bond approved by voters in 1994 (approximately \$1.19 per \$1000 of assessed value), is scheduled to occur in June 2013 and enables the district to issue the new bond without increasing the total bond levy rate. These rates are estimates only and will vary depending on interest rates, growth in the district's total assessed value and other factors.

Argument in Favor:

Measure 24-352 is about one thing: **Improving the Quality of all schools in the Silver Falls School District (SFSD)**. It's our turn to "Pay it Forward."

There has been significant progress in the quality of our local schools over the past few years. But many of our children still don't have a safe school and a well-functioning classroom to go to. The average age of SFSD schools is 60 years. **Schools built years ago need significant updating**; classrooms are inadequate, roofs need repair, plumbing and heating systems are deteriorating, and many classrooms have inadequate lighting, wiring, and electrical outlets for 21st century education.

Measure 24-352 has been placed on the ballot to address the most pressing needs of our school district. It **will provide district wide infrastructure upgrades for equal technology access in each school**. These upgrades are necessary for our children to remain competitive in an ever demanding technologically dependent society.

What If I...?

What if I make a mistake on my ballot?

If you make a mistake, draw a line through the entire measure response or candidate's name. You then can make another choice if desired.

What if I change my mind after I turn in my ballot?

Your ballot has been cast as soon as you deposit it in the mail or at a ballot drop site. After that, you cannot receive a new ballot.

What if I don't vote on everything on the ballot?

Your ballot will be counted.

What if I don't sign my return envelope?

You will be notified by mail that your ballot was received unsigned.

What if I don't receive my ballot?

If you are a registered voter and don't receive your ballot within five days after they are mailed out, call us at Marion County Elections Office at 503-588-5041, 1-800-655-5388, TTY/TDD 503-588-5610.

Can I Vote?

You are eligible to register and vote if:

- You are an Oregon resident.
- You are a U.S. citizen or will be a U.S. citizen before Election Day.
- You are 18 years old by Election Day.
- New registrations must be completed and postmarked by April 30, 2013.

You need to update your registration if:

- You move or change your mailing address.
- You change your name.
- You wish to change your party affiliation.

What if I've moved?

If you are currently registered to vote in Marion County but have moved within the county, you will need to update your registration by providing your current address(es) to the Elections Office in writing and requesting that a ballot be mailed.

From another Oregon County?

If you have been registered in another county in Oregon, but have moved to Marion County, you may still register and be eligible to vote a Marion County ballot.
