## Credit and Debit Cards are Now Accepted in the Tax Office through LexisNexus.

**\*\*Credit & Debit Cards are NOT accepted by mail.\*\***

For card payments in the Tax Office, LexisNexus, the service provider, charges a fee of \$2.50 for debit cards & 2.35%, \$2.50 min, for credit cards.

**If you wish to pay with your Debit Card in person, make sure the amount you intend to pay does not exceed any daily limit imposed by your bank.**

## Credit/Debit Cards & eChecks are Accepted Online & by Phone with Paystation.

## Payments by Mail

Which Address Should I Use?

**PAYMENTS MAILED WITH THE STATEMENT COUPON** should be sent to the address printed on the coupon:

**PAYMENTS WITHOUT THE STATEMENT COUPON** and all other correspondence should be sent to:

**Marion County Tax Collector  
PO Box 2511  
Salem, OR 97308**

If you would like a receipt, include a stamped, self-addressed envelope with your payment.

## POSTMARKS COUNT! PLEASE MAIL EARLY!

If you are mailing your payment within a few days of the due date, **we strongly encourage you** to go into a post office and have them hand-cancel your envelope to ensure it is **postmarked on or before** the due date of **November 15, 2022**.

State law requires that we recognize the postmark date from the US Postal Service as the payment date.

## Payments Though Your Bank's Online Bill Pay Service

If you would like to make a payment through your bank's Online Bill Pay Service, make sure to provide your bank the following information:

- ⇒ Your six-digit Property Tax Account Number
- ⇒ The amount you would like to pay

**Payments with Online Bill Pay should be made at least 14 days prior to the due date to avoid late charges.**
