1. Consider approval of a proclamation designating October 16-22, 2016 as National Hands and Words are Not for Hurting Week in Marion County. — Loryn Studer & Katie Larson, South Salem High School *Summary of presentation:*

- Katie Larson is Miss Marion & Polk County's Outstanding Teen;
- Loryn Studer is the founder of the first annual Suicide Prevention week;
- They are the president and vice president of a club at South Salem High School;
- Main objective is to support their student body;
- Would like to put on several events this school year:
 - O Would like Suicide Prevention week to be an annual event.
- Sponsored Out of the Darkness Riverfront Walk to raise awareness around suicide prevention;
- Created and sold purple shirts to support Suicide Prevention and Hands week;
- Would like to promote Ann Kelly's Hands & Words Are Not For Hurting pledge:
 - o Pledge will be said at all their football games during half-time; and
 - o Will offer purple hair wrap to the other school during volleyball games.
- Have raised over \$2,500 from local business owners and individuals;
- Will promote wearing purple at all volleyball and football games;
- Mission statement defines their desire to get the issue of suicide talked about;
- Katie Larson's platform is, "Not Okay is Okay Too Mental Health for Teens":
 - o Raises awareness of possible contributing factors.

Board discussion:

- Peer support may have more of an impact than teachers and parent input at this age;
- Many mental health issues don't appear until the teen years; and
- Important to recognize when someone is struggling and be available.

MOTION: Commissioner Brentano moved for approval of a proclamation designating October 16-22, 2016 as National Hands and Words are Not for Hurting Week in Marion County. Seconded by Commissioner Carlson; motion carried. A voice vote was unanimous.

- Would like to change to Professional Benefit Services effective January 1, 2017.

3. Consider an order approving the Marion County Children and Families Commission's Bylaws revisions. – Tamra Goettsch

Summary of presentation:

- Children and Families Commission is a section of the Community Services Department which helps the board become more informed of children and families;
- As their role has been defined, the bylaws must be revised per legal counsel recommendation;
- Individual changes in the bylaws were pointed out by Mary Grim, Community Services Program Coordinator:
 - o Recommends retaining minimum membership at eleven and cap at thirty; and
 - O Proposes an honorary member position:
 - Can attend meetings as their schedule allows;
 - Cannot vote:
 - Would not count towards a quorum; and
 - Appoints honorary members a four year term.

Board discussion:

- Honorary members are important for the expertise they lend;
- Important to make sure that the people who serve can attend in order to meet quorum; and
- Cap helps staff manage changes in membership.

MOTION: Commissioner Brentano moved for approval of an order approving the Marion County Children and Families Commission Bylaws revisions. Seconded by Commissioner Carlson; motion carried. A voice vote was unanimous.
