## Summary of presentation:

- Marion County Extension and 4-H Service District was approved by voters in May 2015;
- First formal agreement between 4-H Service District and Marion County;
- Marion County will provide administrative, professional and technical services to support the 4-H Service District:
- 4-H Service District will pay the county a fee for services after one year because no taxes have been collected as yet; and
- Board of Commissioners serves as the governing body to the 4-H Service District.

#### Board discussion:

- County has been providing a number of different administrative services:
  - o Legal services;
  - o Financial management;
  - o Payroll;
  - o Billing;
  - o Contracts; and
  - Providing support for board meetings.

**MOTION:** Commissioner Brentano moved approval of an intergovernmental agreement between Marion County and the Marion County Extension and 4-H Service District to provide administrative, professional, and technical services to support the District through June 30, 2020. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.

**2.** Consider approval of a contract with M.L. Houck Construction Co., in the amount of \$1,556,590.75 for earthwork and drainage on Brown Road between Arizona Avenue and San Francisco Drive. – Cindy Schmitt

## Summary of presentation:

- Requesting board approve contract with M.L. Houck Construction Co.;
- Federally funded project to construct bicycle lanes and sidewalks on Brown Road in the county portion of the street;
- Joint project with City of Salem;
- Success in acquiring construction easements;
- Five bids received for project and M. L. Houck Construction Co. was the successful bidder; and
- Requested the board approve contract today and the contractor is ready to start work immediately.

#### Board discussion:

- Brown Road currently two lane road with ditches;
- Scott Elementary School is accessed directly off of Brown Road;
- There is heavy pedestrian and bicycle traffic;
- Project will widen the lanes and provide sidewalks;
- Project will complete the urban improvement for the section up to San Francisco Drive;
- Distance for improvement is approximately half mile;
- Bid covers the complete cost of the project;
- Pavement portion of project is to include a final overlay on portion in city and a slurry seal for portion in county;
- Total cost of \$2.37 million is entire project cost, including preliminary engineering, the right-of-way acquisition, utility work, and construction;
- Entire project cost is covered at 89.73 percent of federal funds;
- County will have to make up 10.27 percent match and will come from labor to develop the project and make it happen; and
- City of Salem is putting in additional match for their portion of the federal funds that go to the project.

**MOTION:** Commissioner Cameron moved approval of a contract with M.L. Houck Construction Co., in the amount of \$1,556,590.75 for earthwork and drainage on Brown Road between Arizona Avenue and San Francisco Drive. Seconded by Commissioner Brentano; motion carried. A voice vote was unanimous.
