Commissioner Cameron expressed the following in regards to the Marion County Board Session meeting that was held on October 13, 2021:

- The terms of an amended contract on the board session agenda had changed;
- The original contract reflected that Marion County's former and now retired Chief Administrative Officer (CAO) had signed the contract:
  - o The letters NA, Not Applicable, were listed on the signature lines that had been designated for the Marion County Board of Commissioners (BOC);
  - Marion County Legal Counsel reviewed the original document and determined that a board order had been signed by the commissioners in 2016, that authorized the CAO to sign contracts, documents, amendments, and notices that were related to a high-speed ballot envelope sorter on behalf of the BOC; and
  - o All signatures pertaining to the original contract were signed appropriately.
- The Board of Commissioners office is hosting a fundraiser breakfast to benefit the United Way organization:
  - o The fundraiser event is open until 10:00 a.m.; and
  - o Individuals that wish to support the United Way organization are encouraged to attend.

## JUVENILE DEPARTMENT

5. Consider approval of the incoming funds Grant Agreement with the Oregon Department of Education in the amount of \$463,417 to provide Juvenile Crime Prevention (JCP) funding for programs to reduce crime in Marion County communities, retroactive from July 1, 2021, through June 30, 2023. –Troy Gregg

# Summary of presentation:

- The Marion County Juvenile Department obtained the grant through the Youth Development Division (YDD);
- The grant is utilized for the Family Support Program (FSP):
  - o The FSP is an early intervention program;
  - o The program works with youth prior to entering the juvenile system; and
  - o The program receives referrals from some of the following entities that have expressed concern for a youth that may be struggling:
    - Schools:
    - Police departments;
    - Neighbors of the youth; and
    - Family members.

- Two Probation Officers' (PO's) provide some of the following to the youth and their families:
  - o Counseling services;
  - o Support services;
  - o Family support services; and
  - o Referrals.
- The FSP plays an important role in providing early intervention.

- The program serves an estimated 50 youth and their families each year;
- The program focuses on offering support to the parents and family members of a youth that may be struggling:
  - The family members may be concerned with the possibility of the youth interacting with the police:
    - The program provides an opportunity for assistance before the police interaction occurs.
- Prior to the COVID-19 pandemic, there was a waiting list for individuals and families that wished to participate in the program;
- It is important for families to have access to resources:
  - o Community resources may be available;
  - Having an individual available to help families navigate the system to find available resources is important;
  - o Helping families find the right resources at the right time is paramount; and
  - o Lack of resources or finding available resources can be challenging.
- The removal of School Resource Officers (SRO's) in Salem-Keizer Public Schools is concerning:
  - SRO's in Marion County schools are not police officers;
  - o SRO's are positive touch points that help students connect with resources; and
  - o They help prevent youth from continuing further into the criminal justice system.

**MOTION:** Commissioner Willis moved to approve the incoming funds Grant Agreement with the Oregon Department of Education in the amount of \$463,417 to provide Juvenile Crime Prevention (JCP) funding for programs to reduce crime in Marion County communities, retroactive from July 1, 2021, through June 30, 2023. Seconded by Commissioner Bethell; motion carried. A voice vote was unanimous.

## **PUBLIC WORKS**

- 6. Consider approval of an order appointing Brian Sund as Vice-chair of the Solid Waste Management Advisory Council (SWMAC) with a term ending April 30, 2022. –Brian May *Summary of presentation:* 
  - The Solid Waste Management Advisory Council (SWMAC) was established in February 1989:
    - The council provides recommendations to the board of commissioners and environmental services staff on items related to solid waste, which includes some of the following:
      - Reduction:
      - Reuse;
      - Recycling;
      - Compost; and
      - Disposal.
  - Council members are appointed by the board of commissioners and serve a four-year term:
  - SWMAC is comprised of the following:
    - o Eight citizen-at-large positions; and
    - o Eight business and industry positions.
  - Recent activities that council members are addressing include some of the following:
    - Updating and reviewing the master recycling course;
    - o Beta testing the new recycling course;
    - Waste management related to unsheltered individuals:
      - The council team has been strategizing on some of the following:
        - Ways to properly dispose of the waste; and
        - Ways to reduce generation of the material.
      - The team anticipates sharing their findings with other jurisdictions.
    - o Updating the SWMAC Handbook; and
    - Updating the SWMAC bylaws.
  - The Oregon Department of Environmental Quality (DEQ) presented a five-year timeline related to legislation that was recently passed:
    - The legislation will impact future environmental services activities and programs.
  - During a meeting held on September 28, 2021, SWMAC members unanimously approved Mr. Sund's appointment to vice-chair;
  - Mr. Sund has been serving on the council since 2008;
  - Mr. Sund expressed the following:
    - He became interested in recycling in high school where the first Earth Day was celebrated in 1970;
    - o He attended Willamette University and participated in recycling events;
    - o He is a retired teacher;
    - He served as a special educator at South Salem High School (SSHS) for 27 years;
      and

• He started a recycling program during his tenure at SSHS.

#### **Board discussion:**

- The commissioners requested there be ample time to review the updated bylaws before they are voted on during a Marion County Board Session meeting;
- The council has open vacancies for the following:
  - o A Chamber position; and
  - Two Citizen-at-Large positions:
    - Community members are encouraged to apply.
- The commissioners expressed their appreciation to Mr. Sund for volunteering; and
- It is important to have engaged members on the SWMAC board.

**MOTION:** Commissioner Bethell moved to approve an order appointing Brian Sund as Vice-chair of the Solid Waste Management Advisory Council (SWMAC) with a term ending April 30, 2022. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.

7. Consider approval of the incoming funds Intergovernmental Agreement with the Oregon Department of Transportation (ODOT) in the amount of \$800,000 of which an estimated \$717,840 will be paid with federal funds and the county will provide an estimated \$82,160 for the preliminary engineering and right-of-way phase for the State Street: 4106 State Street to 46<sup>th</sup> Avenue Improvement project through October 20, 2031. –Ryan Crowther

# Summary of presentation:

- The project is located on State Street in the City of Salem;
- Currently the street has two lanes traveling in opposite directions;
- Pedestrians are utilizing the bike lanes as a walking path to travel through the corridor;
- The project scope includes some of the following:
  - O Construct a 12-foot continuous turn lane:
    - This allows vehicles to turn into driveways or side roads; and
    - It reduces congestion.
  - O Construct a 6-foot bike lane:
  - o Install planter strips;
  - o Construct a 6-foot sidewalk:
  - o Construct stormwater conveyance and treatment facilities; and
  - o Install two enhanced pedestrian crossings with rectangular rapid flashing beacons:
    - The crossing locations will be determined in the design process once traffic engineers have reviewed the project area.
- Currently the project is only funded through the Preliminary Engineering (PE) phase and the Right-Of-Way (ROW) acquisition phase;
- Funding for the two phases entails the following:
  - o The total estimated expense for PE and ROW is \$800,000;

- An estimated \$717,840 in federal grant funds through the Salem-Keizer Area Transportation Study (SKATS) will be utilized for the project; and
- o The county's contribution is estimated to be \$82,160.
- Public Works staff anticipates utilizing SKATS grant funding for the construction phase of the project:
  - o Currently the construction phase of the project is estimated to be \$3,346,500.
- The preliminary schedule for the project entails the following:
  - o Project design will start in 2022 and extend through 2025;
  - o The Right-Of-Way (ROW) will occur in 2024; and
  - o Construction is estimated to begin in 2026.
- The Intergovernmental Agreement's (IGA's) project term date is 2031:
  - The Oregon Department of Transportation (ODOT) provides 10 years for a project completion date; but
  - The county anticipates the project will be completed in under 10 years.

- Marion County is responsible for providing the ROW acquisitions:
  - o The county utilizes a contractor to perform some of the following:
    - Negotiations; and
    - Appraisals.

**MOTION:** Commissioner Willis moved to approve the incoming funds Intergovernmental Agreement with the Oregon Department of Transportation (ODOT) in the amount of \$800,000 of which an estimated \$717,840 will be paid with federal funds and the county will provide an estimated \$82,160 for the preliminary engineering and right-of-way phase for the State Street: 4106 State Street to 46<sup>th</sup> Avenue Improvement project through October 20, 2031. Seconded by Commissioner Bethell; motion carried. A voice vote was unanimous.

Consider approval of Amendment #1 to the Intergovernmental Agreement with the Oregon Department of Transportation (ODOT) to add \$864,918.88 of which an estimated \$691,689.82 will be paid in federal funds and the county will provide an estimated \$173,229.06 for a new contract total of \$2,907,405.13 for vessel and site improvements to both the Wheatland Ferry and the Buena Vista Ferry through September 30, 2024. –Ryan Crowther

# Summary of presentation:

- The Wheatland Ferry was recently closed for 40 days to allow for ramp improvements:
  - Concrete was poured that needed time to cure and strengthen before the ferry could be utilized.
- The Wheatland Ferry is located north of the City of Keizer;
- The Buena Vista Ferry is located south of the City of Independence;
- The original IGA provided funding for some of the following:

- o Procuring generators for both ferries;
- o Installing the generators at both ferry sites;
- o Constructing tie-off dolphins at the Wheatland Ferry site; and
- o Ramp widening and rehabilitation at the Wheatland Ferry site:
  - The original concrete ramps needed to be removed and concrete was repoured.
- Amendment #1 to the IGA provides additional funding for improvements to the Wheatland Ferry which entails some of the following:
  - o Procure and install new vessel ramp lifts and a steering wench:
    - The current ramps are held by a cable;
    - The ramp lifts will be utilized to raise and lower the ramps; and
    - The lifts will improve operations for the ferry operator.
  - o Hatch covers and lighting will be installed; and
  - o Construct catwalks on the towers.
- The complete project budget to date entails the following:
  - o The budget for the original IGA was \$2,042,486.25;
  - o Amendment #1 adds the following:
    - An estimated \$691,689.82 in federal funding; and
    - An estimated \$173,229.06 will be provided by the county.
  - o The new project total is estimated to be \$2,907,405.13.
- The project funding has a short turn-around time for the funds to be utilized:
  - The county has three years to utilize the funding once the funds have been received.
- The preliminary schedule for the project entails the following:
  - o Project design will start in 2021 and end in 2022; and
  - o Construction improvements are estimated to begin in 2023.

- Road funds will be utilized to finance Marion County's portion for the project;
- It is anticipated that neighboring Yamhill County will provide some funding for the project:
  - o Yamhill County residents will also benefit from the ferry improvements.
- Ferries may contribute to a reduction in emissions;
- Community members have the option to park their vehicles and walk onto a ferry to cross the river;
- Supply constraints have delayed the arrival of the generators:
  - o The county anticipates the generators to arrive in the month of December.
- The generators will benefit both Marion and Yamhill Counties in the event of a power outage; and
- The generators will be installed at a higher elevation to prevent damage in the event the river rises to flooding levels.

**MOTION:** Commissioner Bethell moved to approve Amendment #1 to the Intergovernmental Agreement with the Oregon Department of Transportation (ODOT) to add \$864,918.88 of which an estimated \$691,689.82 will be paid in federal funds and the county will provide an estimated \$173,229.06 for a new contract total of \$2,907,405.13 for vessel and site improvements to both the Wheatland ferry and the Buena Vista ferry through September 30, 2024. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.

\*\*\* Please note, a motion error was discovered while processing the minutes for Action Item #8. A motion was made to approve Amendment #1 to the Intergovernmental Agreement with the Oregon Department of Transportation to add \$864,918.88 of which an estimated \$961,689.82 will be paid in federal funds. The actual federal funds contribution is \$691,689.82. The total amendment amount of \$864,918.88 was correct.

- 9. Consider approval of the Public Improvement Agreement with Brown Contracting, Inc., in the amount of \$516,120 of which an estimated \$475,965.86 will be paid with state funds and an estimated \$40,154.14 will be paid by the county for the Marion County Intersections Improvements project through December 31, 2022. –Ryan Crowther *Summary of presentation:* 
  - Project improvements will be performed at the following two locations:
    - o The intersection of Ehlen Road and Butteville Road; and
    - o The intersection of Silverton Road and Brush Creek Drive.
  - The project improvements include some of the following:
    - o Construct advanced warning flashers on the following primary roads:
      - Ehlen Road: and
      - Silverton Road.
    - o Install vehicle detections on the approaching roadways:
      - Amber warning flashers on the signage will flash when a car approaches the intersection from the following two side roads:
        - Butteville Road; and
        - Brush Creek Drive.
    - Enhanced stop warnings on the approaching two roadways will be installed:
      - A red flashing beacon will be installed above the stop sign to draw a driver's attention.
    - Raised thermal plastic strips or rumble strips will transverse across Brush Creek
      Drive:
      - The rumble strips will alert drivers to an approaching stop sign.
    - o Lighting will be constructed at both intersections to improve visibility at night.
  - The project is funded through ODOT's All Roads Transportation Safety Grant Program;
  - Brown Contracting, Inc. submitted the lowest project bid of \$516,120:
    - o State funding for the project is estimated to be \$475,965.86; and

- o The county will fund an estimated \$40,154.14.
- Construction will begin in October 2021; and
- It is anticipated that construction will be complete by December 31, 2021.

• The project improvements will assist with corridor safety.

**MOTION:** Commissioner Willis moved to approve the Public Improvement Agreement with Brown Contracting, Inc., in the amount of \$516,120 of which an estimated \$475,965.86 will be paid with state funds and an estimated \$40,154.14 will be paid by the county for the Marion County Intersections Improvements project through December 31, 2022. Seconded by Commissioner Bethell; motion carried. A voice vote was unanimous
