PUBLIC COMMENT

Michael Johnson:

- Mr. Johnson is a representative for the following:
 - o The East Salem Suburban Neighborhood Association; and
 - o The Oregon State University Master Gardeners.
- Mr. Johnson expressed the following:
 - o He has concerns with cars exceeding the speed limit in the neighborhood;
 - o Some residents may be buying and selling cars in the neighborhood:
 - Multiple cars are being parked on the street; and
 - The parked cars are causing street congestion.
 - O There is concern of year-round or constant garage sales:
 - Sale items can be found in yards.
 - o He expressed concerns with a body of water located on the south parking lot of the new Marion County Health and Human Services (MCHHS) building;
 - o Mr. Johnson invited the commissioners to attend an upcoming neighborhood association meeting on November 2, 2023:
 - Marion County Public Works staff will be attending; and
 - The primary focus of the meeting entails:
 - Future transportation activities for the following:
 - o Alma Avenue:

- o State Street;
- o Center Street; and
- o Connecticut Avenue.
- Speeding traffic on the following:
 - o Shenandoah Drive;
 - o Shawnee Drive; and
 - o Pennsylvania Avenue.

Board discussion:

- Marion County Business Services has been working to address the body of water located at the new MCHHS building:
 - o The standing water is due to the recent remodel and new construction.
- The Marion County Sheriff has been invited to the upcoming neighborhood association meeting;
- A neighborhood association meeting invitation may be extended to Oregon Representative Ed Diehl;
- A Transportation Work Session meeting was recently held:
 - A future transportation plan that encompasses a portion of Cordon Road and areas of east Salem was discussed;
 - o Area concerns in the dense communities include:
 - Congestion;
 - Lack of safety; and
 - Crime.
 - O The area has a heavy population rate:
 - The severe cost of housing and inflation has led to multiple families residing in one home.

BUSINESS SERVICES

1. Consider approval of an order to adopt both revised Marion County Administrative Policy #508 and the addition of Procedure #508-A, Employee Exposure Control to Bloodborne Pathogens. –Justine Flora and William White

Summary of presentation:

- Bloodborne Pathogens Administrative Policy #508 was originally adopted in 1992;
- The policy was last reviewed in 1996;
- The current policy is lengthy and includes:
 - o Detailed policy language; and
 - o Detailed procedure language.
- Staff recommended a redesign of the policy:
 - o Language will decrease; and
 - o A new procedure document will be added:
 - Provides framework for individual departments;
 - Different departments require different programs that relate to specific jobs; and
 - It is difficult to have one policy that covers all the county departments.
- Different positions throughout the county need to be assessed;
- Procedures will be created for specific jobs that deal with specific exposures; and
- Training is provided to help keep departments up to date.

Board discussion:

• Policy #508 was discussed in detail at a prior meeting.

MOTION: Commissioner Cameron moved to approve an order to adopt both revised Marion County Administrative Policy #508 and the addition of Procedure #508-A, Employee Exposure Control to Bloodborne Pathogens. Seconded by Commissioner Bethell; motion carried. A voice vote was unanimous.

2. Consider approval of an order to readopt for 2023, Marion County Administrative Policy #496, Investment of Public Funds. –Sherry Downs

Summary of presentation:

- Oregon Revised Statute (ORS) 294.135(a) requires local governments investing in securities with maturities longer than 18 months to annually adopt their investment policy;
- The county does invest in securities with maturities longer than 18 months;

- Staff is requesting that Administrative Policy #496, Investment of Public Funds, be readopted for 2023; and
- There are no changes to the prior policy.

Board discussion:

• The Marion County Finance Department and the Marion County Treasurer's Office collaborate on the investment of public funds.

Motion: Commissioner Bethell moved to approve the readoption for 2023, Marion County Administrative Policy #496, Investment of Public Funds. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.

3. Consider approval of Amendment #1 to the incoming funds Intergovernmental Agreement with the Oregon Health Authority to add \$131,249.57 for Program Element (PE) 13, Tobacco Prevention and Education Program (TPEP), for a new contract total of \$4,988,730.08 through June 30, 2025. —Ryan Matthews

Summary of presentation:

- This is an amendment to the 2023-2025 biennium Intergovernmental Agreement (IGA) with the Oregon Health Authority (OHA) for public health services;
- Amendment #1 adds funding in the amount of \$131,249.57;
- Funding will be utilized for Program Element (PE) 13, Tobacco Prevention and Education Program (TPEP);
- The initial OHA contract for public health services provided bridge funding for the first quarter:
 - This allowed funding and services to continue while the budget authority was being determined; and
 - o Additional funding provides for programs through June 30, 2025.
- Amendment #1 provides funding specifically for PE13, Tobacco Prevention and Education Program (TPEP);
- It is anticipated that more amendments will be coming in future months for other PE's;
- These specific funds will be utilized for smoking prevention and awareness services and resources including:
 - o A tobacco quit hotline;
 - o Performing surveys;
 - o Collecting data focused on youth tobacco usage;
 - o Collaborating with schools to educate youth and parents;
 - Providing resources to teachers for youth referrals;
 - o Educating the community on the health risk of tobacco; and

o Building awareness of the available resources for smoking prevention.

Board discussion:

- Staff does not provide any regulatory oversight or enforcement;
- Staff is available to advise businesses on proper techniques including:
 - o Checking identifications; and
 - o Not selling to minors.
- The program currently provides the community with education for the following:
 - o Laws and regulations;
 - o The impacts of tobacco usage; and
 - o Available resources to quit tobacco use.
- The county opted out of a licensing fee for tobacco distribution.

MOTION: Commissioner Cameron moved to approve Amendment #1 to the incoming funds Intergovernmental Agreement with the Oregon Health Authority to add \$131,249.57 for Program Element (PE) 13, Tobacco Prevention and Education Program (TPEP), for a new contract total of \$4,988,730.08 through June 30, 2025. Seconded by Commissioner Bethell; motion carried. A voice vote was unanimous.

4. Consider approval of Amendment #4 to the incoming funds Contract for Services with Salem Health to add \$100,000 for a new contract total of \$300,000 and extend the term date through August 31, 2024, to provide mental health screening services at the hospital's emergency department. –Debbie Wells

Summary of presentation:

- Amendment #4 provides for the following:
 - o Reinstates the current contract;
 - o Increases the contract funding by \$100,0000; and
 - o Extends the contract term date to August 31, 2024.
- Marion County has a longstanding relationship with Salem Health Hospitals and Clinics;
- Marion County Health and Human Services (MCHHS) provides mental health assessments at Salem Health's emergency department as needed;
- The additional funding is an added source of income for MCHHS's program at the Psychiatric Crisis Center (PCC);

Board discussion:

None.

MOTION: Commissioner Bethell moved to approve Amendment #4 to the incoming funds Contract for Services with Salem Health to add \$100,000 for a new contract total of \$300,000 and extend the term date through August 31, 2024, to provide mental health screening services at the hospital's emergency department. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.

Board discussion:

Commissioner Bethell expressed the following regarding Oregon Measure 110:

- Oregon Senator Kate Lieber is leading a conversation and a committee to bring potential changes to Measure 110 in the short session;
- Measure 110 has created a system of care that is failing;
- The public needs to be aware and encourage their elected officials to be proactive in repealing or reforming the measure;
- There have been overdoses resulting in the death of adults and youth;
- Oregon Legislature is meeting in November:
 - O Citizens are encouraged to appear and show support for the repeal of Oregon Measure 110.
- Citizens are encouraged to contact Oregon Senators to express their concerns and advise their representatives of what they would like to see occur with Oregon Measure 110; and
- Senators were elected to work for and support the citizens.

Commissioner Cameron expressed the following:

- Oregon Representative Kevin Mannix has been appointed to the committee;
- The public needs to speak on how Measure 110 has negatively impacted their neighborhoods and cities;
- The ballot measure was misleading to the voters; and
- There needs to be accountability in the system.

Commissioner Willis expressed the following:

- People do not want to put individuals in prison just because they have an addiction issue;
- The creators of Oregon Measure 110 have an anti-law enforcement philosophy:
 - o They do not see the police as part of the solution.
- Individuals are dying on our streets;
- This is an opportunity to fix the problem;
- Polls show the public sees the damage and they would like the following:
 - o For people to be taken care of; and
 - o There needs to be accountability.
