Summary of presentation:

- Amendment #2 to the incoming funds Intergovernmental Agreement (IGA) with the Oregon Health Authority (OHA) increases funding in the amount of \$1,967,895.05:
 - o The new contract total will be \$6,956,625.13.
- The contract funds an array of public health services;
- The goal of the initial contract with OHA was to ensure that there was no disruption in funding or services for counties:
 - O At the time of the initial contract there was not full budgetary authority;
 - o Knowledge of where the budget was coming from was unknown; and
 - o Bridge funding was provided for the initial contract for the months of July through September.
- Amendment #1 that was presented at a prior board session meeting, and Amendment #2, both provide additional bridge funding for the months of October through June;
- Amendment #2 provides funding for three Program Elements (PE):
 - o PE01-01, State Support for Public Health:
 - Primarily supports communicable disease control and response within the county;
 - Funding in the amount of \$326,328 is being added; and
 - It is anticipated that the funding will last through the contracts ending term date of June 30, 2024.
 - o PE12-01, Public Health Emergency Preparedness (PHEP) and Response:
 - Funding in the amount of \$108,155.25 is being added; and
 - It is anticipated that the funding will last through the contracts ending term date of June 30, 2024.
 - PE51-01, Local Public Health Authority (LPHA) Leadership, Governance, and Program Implementation:
 - This is public health modernization funding;
 - Funding will be more than what was originally anticipated:
 - Funding in the amount of \$1,533,501.80 is being added; and

- The county only received \$321,000 for the first quarter of the fiscal year.
- The public health system primarily provided individual services in a clinical setting;
- Public health modernization focuses on population health:
 - Interacts with systems; and
 - Ensures the overall health of the population by providing:
 - o Education;
 - o Awareness; and
 - Access to care.
- Four foundational areas for public health modernization include:
 - Communicable disease control;
 - Environmental health;
 - Prevention and health promotion; and
 - Access to clinical services.
- It is anticipated that additional PEs not included in this contract will come forward in the future including:
 - o Covid-19 funding; and
 - o Tobacco prevention funding.
