TITLE		Designation of newspaper for publication of 2021 tax foreclosure list.						
Issue, Description & Background		ORS 312.040 requires the Board of Commissioners to designate a newspaper of general circulation in the county for publication of the annual tax foreclosure list. This is the opening step in the annual tax foreclosure process. The Woodburn Independent fulfills these requirements.						
Financial Impacts:		Pursuant to ORS 312.040 and 193.090, the ad cost may not exceed the Woodburn Independent's open display ad rate (the per column inch rate charged local advertisers not under contract for a fixed rate or minimum quantity of advertising).						
Impacts to Department & External Agencies		None.						
Options for Consideration:		1. Designate the Woodburn Independent as the newspaper for publication of the 2021 tax foreclosure list; 2. Take no action at this time.						
Recommendation:		It is recommended that the Board designate the Woodburn Independent as the newspaper for publication of the 2021 foreclosure list at this time. The Board is statutorily required to designate a newspaper of general circulation in the county for publication of the foreclosure list, and the Woodburn Independent meets the statutory requirements.
