Board Appointment – Justice of the Peace Pro Tempore

- 6. Consider approval of an order appointing Jarrod Howard as the Justice of the Peace Pro Tempore for the Marion County Justice of the Peace District.
- -Justin Kidd, Marion County Justice of the Peace

# Summary of presentation:

- Justice of the Peace Kidd is asking the Board to approve a pro tempore who can serve in his place when he is absent:
  - o He suggests that Jarrod Howard be appointed to the position.
- Mr. Howard is a 2009 graduate of Willamette University Law School, and he is the principal owner of the Howard Law Group which specializes in real estate;
- The Justice Court handles a lot of cases related to traffic, and a lot of cases related to real estate in the form of FED eviction work; and
- Mr. Howard has experience with eviction cases.

# Jarrod Howard:

- Mr. Howard has always lived in Oregon, and he currently resides in Marion County;
- He was a business owner before he attended law school;
- He started his own law firm, Howard Law Group, in 2009:
  - o They handle specialized, complex transactional work; and
  - o They handle a lot of eviction cases.

- Mr. Howard has appeared in Justice Court; and
- Mr. Howard enjoys practicing law, and he is excited about the opportunity before the Board today:
  - o It would allow him to experience working in the legal field in a different capacity, and to engage with the community.

#### **Board discussion:**

- Being involved in our community is important;
- Eviction numbers are up statewide;
- Eviction cases must be filed in the place of the residence;
- Previously FED cases were only heard in Circuit Court, but now they are being filed in both Circuit Court and Justice Court:
  - o The prior Justice of the Peace did not hear eviction cases; and
  - The majority of FED cases being filed in Justice Court are being filed by self-represented landlords and tenants.
- Judge Kidd sees the court's coordination with the Housing Authority as a major benefit to both parties in eviction cases as most individuals are allowed to stay in their residence and most landlords get paid;
- Part of the reason that the Housing Authority still has funding to help individuals in the eviction process is because the Board was very intentional in making sure that the money the county received for eviction relief was spent on individuals who were in Marion County, they were doing the right thing, they were trying to pay their rent, and yet they were having a difficult time:
  - o The county received criticism for being very prudent with the funds;
  - The county transferred the funds to the Housing Authority because they are housing experts, and they provide housing case management; and
  - o The funding has been a benefit to both landlords and tenants.
- The Housing Authority will likely run out of these funds in the next couple of months, but new funds should be available:
  - The governor declared an executive order on housing which focuses on prevention, shelter housing, and stabilized housing; and
  - o \$14 million has been allocated to the Marion/Polk region.

**MOTION:** Commissioner Bethell moved to approve an order appointing Jarrod Howard as the Justice of the Peace Pro Tempore for the Marion County Justice of the Peace District. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.

# Summary of presentation:

- In accordance with local budget law and county policies Mr. Adatto presented the second supplemental budget for fiscal year 2022-2023;
- The request is increasing the county budget by \$210,483, bringing the total county budget to \$715,693,173;

- Public notice of the hearing was posted in the *Woodburn Independent* on March 1, 2023, and copies have been available for review on the county's website and in the Board of Commissioners office;
- The supplemental budget has been reviewed in detail by the Commissioners during a Management Update meeting;
- Within the supplemental budget a net total of 2.0 full time equivalent (FTE) were added across all departments;
- The budgets of 12 funds were modified;
- Budget detail is included in the supporting pages of the second supplemental budget beginning on page 4:
  - The Central Services Fund had changes within appropriation categories with zero net impact, so they are not included in the budget detail:
    - The Information Technology Department reallocated \$439,854 to materials and services for contracted staffing due to position vacancies.
- The budget team plans to bring a third supplemental budget to the Board in May or June.

#### Board discussion:

- The Commissioners reviewed the budget in detail at a work session meeting; and
- Commissioner Willis noted for the record that no one signed up for public comment.

**MOTION:** Commissioner Bethell moved to close the public hearing and approve a resolution to adopt the Fiscal Year 2022-23 Second Supplemental Budget. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.
