# Summary of presentation:

Tamra Goettsch:

- Ms. Goettsch would like to welcome everyone to opening day at the Marion County Fair; and
- Ms. Goettsch would also like to acknowledge the partnership the county has with the Oregon State Fair and Exposition Center:
  - The county has an agreement with the Oregon State Fair Council to utilize the facilities and the fairgrounds for the Marion County Fair.

#### Mike Paluszak:

• Mr. Paluszak would like to thank the board of commissioners and welcome them;

- He states hundreds of events are held each year at the fairgrounds; and
- The Marion County Fair and the county's partnership with the Oregon State Fair Council have led to Capitol Improvement Projects such as asphalt improvements on the fairgrounds:
  - O Rent fees are exchanged for paving work.

#### Joel Conder:

- Mr. Conder is a Marion County Fair Board member; and
- He would like to express his appreciation to the commissioners for the following:
  - O Their continued support of the county fair; and
  - O For having a shade structure installed for this year's county fair:
    - The shade structure is expected to supply relief from the elements for individuals attending the fair.

#### Mike Adams:

    - Individuals paying admission into the county fair can get into the rodeo for free.

Approve Amendment #1 to the Contract for Services with Trinity Service Group, Inc. in the amount of \$150,000 for a total of \$400,000 for food management services for the Juvenile Department; remove the United States Department of Agriculture National School Breakfast Program, and the National Lunch Program from the contract.

Approve Amendment #2 to the Contract for Services with Cappelli Miles to add \$20,000 for a total of \$634,050 and extend media planning services through July 31, 2019.

# TREASURER'S OFFICE

### HEALTH AND HUMAN SERVICES

1. Consider approval of the Intergovernmental Agreement with the Oregon Health and Sciences University in the amount of \$366,225 to provide Title V Maternal and Child Services Block Grant through June 30, 2024. –Katrina Rothenberger and Patty Vega

# Summary of presentation:

- The agreement term is retroactive from October 1, 2018 through September 30, 2024;
- Children ages 0-21, with special health care needs, can receive in-home visits from a nurse:
  - o This service is provided regardless of insurance status or family income.
- A Shared Plan of Care is another service that is provided:
  - The service develops a care plan that enhances communications between the following:
    - Family members;
    - Primary care providers;
    - Education representatives;
    - Mental health representatives;
    - Behavioral health representatives;
    - Public health representatives; and
    - The individual dispersing payment.

# Board discussion:

- Oregon Health and Sciences University receives funding from the following:
  - o The Health Resources and Services Administration; and
  - The Oregon Health Authority.
- Parents of the children have the option to accept or refuse in-home visits from nurses;
- Nurses going into homes provide the following:
  - o Help;
  - o Information; and
  - o Coaching.
- Families can receive help for some of the following:
  - o Heart disease;
  - o Spina bifida;

- o Brain injuries; and
- o Fetal alcohol spectrum disorder.

**MOTION:** Commissioner Brentano moved to approve the Intergovernmental Agreement with the Oregon Health and Sciences University in the amount of \$366,225 to provide Title V Maternal and Child Services Block Grant through June 30, 2024. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.

### **PUBLIC WORKS**

2. Consider approval of the Public Improvement Agreement with Pave Northwest, Inc. for \$295,632.73 for furnishing and application of Type II Slurry Seal on various roads in Marion County, the City of Salem, and the City of Stayton. —Brian Nicholas and Ryan Crowther *Summary of presentation:* 

- Every year the Public Works Department solicits for the furnishing and application of Type II Slurry Seal for county roads;
- The slurry seal extends the service life of county roadways as well as roadways in neighboring jurisdictions;
- The 2019 contract covers slurry sealing for the following:
  - o Twenty-six sections of county roadway that totals 2.84 miles;
  - o The Spongs Landing Park entrance and parking lot;
  - o Nineteen sections of roadway for the City of Salem;
  - o The Willow Lake Wastewater Treatment Plant; and
  - o Seventeen sections of roadway for the City of Stayton.
- The City of Salem and the City of Stayton will reimburse the county for slurry seal services that fall under their jurisdictions;
- On April 4, 2019, the Public Works Department received four bids for the slurry seal projects;
- The estimated bids for the projects ranged from \$295,632.73 to \$417,228.05:
  - o Pave Northwest Inc. submitted the lowest bid.
- Public Works recommends the approval of the contract with Pave Northwest Inc. for the furnishing and application of Type II Slurry Seal.

### Board discussion:

- It is more cost effective for the county, the City of Salem, and the City of Stayton to join together for slurry seal services:
  - A price reduction is received for larger orders;
  - o Jurisdictions are able to pay less and expand their slurry sealing areas:
    - Jurisdictions have stated that it is not feasible for them to have their own contract for slurry seal.
- The county budgets an estimated \$100,000 to \$150,000 a year for slurry seal;
- A large portion of the sealing is done on residential streets:

- o Impact to the neighborhoods is minimal; and
- o It extends the life of the streets for areas with low freight traffic.
- The City of Salem approached the county in 2016 with the intent of joining together on a contract for slurry seal services;
- The joint venture had the following results:
  - o The value of the bid package tripled;
  - O Time was reduced in manpower and labor for the following:
    - Developing the contract;
    - Submitting the contract for bids; and
    - Managing the work out in the field.
  - o The increased volume of work resulted in improved bid prices; and
  - Other jurisdictions have joined in the slurry seal program.
- The county is able to help smaller communities by leveraging for a larger slurry sealing contract;
- The program has been in a trial stage; and
- The Public Works Department plans to open the program up to all jurisdictions county wide in the future.

**MOTION:** Commissioner Willis moved to approve the Public Improvement Agreement with Pave Northwest, Inc. for \$295,632.73 for furnishing and application of Type II Slurry Seal on various roads in Marion County, the City of Salem, and the City of Stayton. Seconded by Commissioner Brentano; motion carried. A voice vote was unanimous.
