## David Beem:

• Mr. Beem requested more services for homeless youth:

o There is no access to mental health services after 5:00 p.m.

#### Tina Herman:

- Ms. Herman lives in the Macleay area;
- She spoke in opposition to the Auburn Conversion Project:
  - o Converting an old landfill into a community park; and
  - The land was purchased with Land and Water Conservation Fund (LWCF) money.
- The project would have to be approved by the LWCF and other government organizations due to it once being a landfill:
  - These approvals could take years.
- There have been no environmental impact surveys, well water samples, or soil samples collected since 1991;
- The town hall scheduled for March 2020 was cancelled due to COVID, and has not been rescheduled:
  - Macleay residents would like an opportunity to express their opinions on the project.

- Ms. Herman was told by Marion County Environmental Services that the county cannot apply for funding to restore parks destroyed by the fires until the Auburn Conversion Project is satisfied:
  - O She feels that funds would be better spent restoring Santiam Canyon parks, and that these projects could be completed in a timelier manner.
- Ms. Herman asked the commissioners to vote against the Auburn Conversion Project.

#### Duane F. Marks:

- Mr. Marks spoke in opposition to the Auburn Conversion Project;
- He feels the money should be directed to maintaining existing Marion County parks;
- The Environmental Protection Agency (EPA) and the Department of Environmental Quality (DEQ) have strict regulations that would have to be followed:
  - o This would cost a lot of money.
- Marion County taxpayers do not want to fund the project; and
- Mr. Marks feels the project is going to be very expensive.

## Heather Croser:

- Ms. Croser spoke in opposition to the Auburn Conversion Project;
- A large natural gas pipeline runs under the center of the old landfill;
- Landfills emit methane gas which is odorless and colorless, and also highly flammable;
- Ms. Croser is concerned that if the land is turned into a park there is a high potential for an explosion or a fire; and
- Flammable items were left on the property and they have not been completely removed.

# Sheryl Derting:

- Ms. Derting lives adjacent to the landfill;
- She has serious concerns with turning the landfill into a park:
  - O She feels there are hazardous conditions present at the landfill; and
  - O She is worried about fires being started by park users:
    - There is no fire station in close proximity to the landfill.
- Ms. Derting feels turning the land into a wildlife refuge would be a better use of the land as it is already home to the following wildlife:
  - o Deer:
  - o Foxes:
  - o Birds:
  - o Coyotes; and

- o Cougars.
- These animals are quickly losing available land to live on.

#### John Drzal:

- Mr. Drzal spoke in opposition to the Auburn Conversion Project;
- He feels a community park is inappropriate for the site:
  - A community park would see large numbers of people coming into the neighborhood; and
  - o Property values would go down.
- Mr. Drzal feels the land should be designated a natural area or open space;
- The county's Parks Master Plan states that the landfill property should be managed as a permanent, undeveloped green space with low level recreational use; and
- The board should not force a park on a neighborhood that does not want it.

# Phyllis Bond:

- Ms. Bond lives approximately a half mile from the proposed park site;
- She is concerned about the Auburn Conversion Project;
- Public Works held a meeting on the project on July 15, 2021;
- A survey was sent out to the neighborhood asking for input on the project:
  - o Most residents within one mile of the project did not receive the survey; and
  - o Residents were told that they could not add input to the survey results.
- The local community does not support the project;
- At the July 15<sup>th</sup> meeting, Public Works stated that this is the only site they will be recommending to the Parks Commission:
  - Ms. Bond feels there has to be other areas within Marion County that can serve as a park.
- Ms. Bond asked the board to stop the project.

#### Lars Schroeder:

- Mr. Schroeder lives approximately a quarter mile from the proposed park site;
- He visited Bonesteele Park:
  - o Illicit activity occurs at Bonesteele Park.
- The proposed park site is very isolated:
  - o Mr. Schroeder feels it will be a magnet for illicit activity.
- Mr. Schroeder is concerned with what his neighborhood would turn into if the proposed park was developed; and

• New parks should not be developed when existing Marion County parks are not properly maintained.

# Stacey Crowell:

- Ms. Crowell lives next door to the proposed park site;
- She is concerned with neighborhood safety if the park is developed:
  - o Concerned with potential drug activity;
  - o Concerned with children potentially being harmed by park users;
  - o It will be hard for park users to tell where the park land stops and her land starts;
  - The proposed park land is very isolated:
    - She is concerned there will not be enough resources for the park to be patrolled for safety.
  - O She is concerned homeless individuals will be allowed to camp at the park.
- Ms. Crowell is concerned about the safety of her children if the park is developed.

#### Patricia Parks:

- Ms. Parks lives across the street from the proposed park site;
- Residents in the area do not want a community park in their neighborhood:
  - o It would dramatically change the lifestyle of the area.
- Neighbors all know each other;
- Gene Johnson was not able to attend so Ms. Parks read some comments on his behalf:
  - o Mr. Johnson's family has lived in the area for a long time;
  - O He is concerned with the maintenance of the proposed park:
    - Concerned with the increased fire risk of an unmaintained park.
  - o He is concerned with methane pockets and the gas pipeline already at the site.
- There is a large amount of concern over the project.

#### Tom Parks:

- Mr. Parks has heard there are two potential uses being proposed for the park:
  - o Frisbee golf; and
  - o A bike park:
    - Neighborhood children would ride bikes to the park;
    - Macleay Road is a 55-m.p.h. road with no bike lane; and
    - It is very dangerous to ride a bike down Macleay Road, and it would be the only road that would have access to the proposed park.

## Sharon Schaberg:

- Ms. Schaberg has lived near the proposed park site for almost 40 years;
- The Macleay area is a great community;
- Individuals within the community walk and bike regularly, and they would be negatively affected by traffic headed to the proposed park;
- The community does not want a park:
  - o A park would not benefit the community surrounding the proposed site.
- It would be a good idea to turn the site into a wildlife area; and
- Ms. Schaberg asked the board to not put a park at the proposed site.

#### Jennifer Tinseth:

- Ms. Tinseth is concerned with the safety of the roads in the area if the Auburn Conversion Project is approved:
  - o Traffic would increase; and
  - o The roads are already unsafe:
    - There are many blind spots in the area;
    - Drivers unfamiliar with the roads run stop signs;
    - There are no bike lanes; and
    - Some stretches of road have no shoulder.
- She can hear sound from activities in the area at her property; and
- Ms. Tinseth asked the board that if the park does get built, that they please make the roads in the area safer.

# Jerry Magee:

- The neighborhood held a town hall last night with over 75 residents in attendance:
  - Neighbors who don't live right next to the proposed park site are also concerned with the project.
- Mr. Magee agrees with everything that has been said by neighbors who spoke before him:
- He is concerned with homeless individuals residing in the proposed park:
  - o Parks have been opened up before for homeless individuals to camp in;
  - o Potential for drug and alcohol use; and
  - Potential for fires.
- Mr. Magee is concerned for his community, and would like to see the park put somewhere else.

#### Tina Herman:

- Ms. Herman spoke for a second time;
- She lives one property away from the proposed park site;
- She has not received a firm answer from the county on how House Bill 3115 will affect the properties around the proposed park;
- There is a gun club that does target practice on property right next to the proposed park site:
- The project could be tied up for years with DEQ; and
- The community asks the board to look for a different property to develop.

### **Board discussion:**

- The board thanked everyone for attending, and for their input;
- The board has received many emails from Macleay area residents;
- Community members are invited to attend the board's Work Session tomorrow:
  - O Staff from the parks department will be attendance.
- The board suggested that Ms. Tinseth reach out to the county's engineering division manager, Lani Radtke, to discuss the safety concerns she has;
- Commissioner Cameron explained the process being followed:
  - The money allocated for the Auburn Conversion Project has to be spent on a conversion of land to a park;
  - o Currently the board is in the information gathering process;
  - O No decisions have been made:
    - No decision will be made until the board has the opportunity to visit the community with the parks department.
  - Tomorrow is a work session where staff will provide the board with input and recommendations:
    - Work sessions are public meetings where the public may attend, but public comment is not accepted.
- Marion County Fire District #1 is not run by the county.

## **PRESENTATION**

Wildfire recovery update. -Scott McClure

- Mr. McClure presented a Santiam Canyon Disaster Recovery Report that details the wildfire recovery efforts in the Santiam Canyon as of July 21, 2021:
  - o It has been 10 months since the Santiam Canyon wildfires;
  - An estimated 27 percent of homes requiring repair or replacement have received building permits;
  - An estimated 38 percent of homes requiring repair or replacement have received septic permits;

- o Almost half of the home sites have been cleaned up;
- An estimated 37% of hazardous trees have been removed:
- O County led recovery projects update:
  - All contractors are in place;
  - By next week all projects will have begun;
  - Financial needs analysis:
    - Ongoing, making progress.
  - Communications and outreach:
    - An overall communications and outreach plan is being developed:
      - Where is information coming from and how should it be distributed.
    - Funding was received to develop a website similar to the existing Santiam Recovery website:
      - Working on how to partner with the existing site so efforts are not duplicated.
    - The City of Gates does not have a website:
      - Working with Gates to determine the scope of the project and what the website could potentially look like.
  - Economic impact and opportunities analysis:
    - The company ECONorthwest will be starting this work next week.
  - Health impact assessment:
    - This work will start next week.
  - Community visioning and strategic plans:
    - The company Better City received the contract and initiated work;
    - Working on getting a compilation of people that will be contacted directly;
    - Working on a survey that will be distributed; and
    - Canyon site visit next week.
- The after-action report will be tomorrow, July 22nd at 6:30 p.m. at Santiam High School:
  - What went well and what improvements could be made in the response to the wildfires.
- o Mr. McClure met with the Mill City city recorder to discuss recovery efforts;
- o The housing team developed a proposed list of projects for State funding; and
- o There is a dust control issue in Detroit due to the loss of trees and vegetation.

- Experienced city managers have been hired to work with the City of Detroit and the City of Gates;
- Marion County has hired a contractor that will apply dust control measures tomorrow and Friday in Detroit:
  - o Dust control will be applied on specific streets.

- The wind pattern in Detroit has changed due to the loss of trees and vegetation;
- Residents are suffering from sinus infections and other health problems due to the dust;
- The dust will potentially be a three to four-year problem until vegetation grows back; and
- Commissioner Bethell commented on Mr. McClure's housing report:
  - o Five proposals have been submitted to the State:
    - One is for permanent housing; and
    - Four are for temporary housing for use as people rebuild.

## **BUSINESS SERVICES**

1. Consider approval of a Lease Agreement with 2755 Partners, LLC in the amount of \$649,563.59 for leased building space for the Health and Human Services Department through July 31, 2023. –Ryan Matthews

# Summary of presentation:

- During the past year and a half, the Health and Human Services Department (HHS) has had unprecedented growth:
  - A lot of the growth has been in the Public Health Division in response to the COVID-19 pandemic; and
  - o Several other programs have also seen significant growth.
- More leased space is needed to safely accommodate HHS workforce and those served;
- HHS is working on a long-term solution:
  - O Building a new facility on the grounds of the Center Street campus:
    - Current projections show completion in two to three years.
- The leased office space would be a temporary location for use while the new facility is being built:

- The leased space does not require any improvements;
- o The building is in an ideal location; and
- The space has an Information Technology training room that will be very useful in training HHS staff.

- Schedule A lists operating expense exclusions, items the county will not be paying for that are the landlord's responsibility;
- The lease has an escalation clause;
- There are currently no other tenants in the building;
- The cost of janitorial services will be paid for by the county to the landlord:
  - o It is cost effective to have janitorial services provided by the landlord.
- The leased space will be utilized for administrative services, not for services accessed by the public; and
- Ms. Vetto clarified that in addition to rent the county is agreeing to pay certain operating expenses:
  - O Schedule A lists items that the county does not consider to be operating expense; and
  - o There is a cap on operating expense.

# Summary of presentation:

- This is typically a one-year agreement;
- The Marine Board asked the Sheriff's Office for a longer agreement:
  - o The Sheriff's Office supports a longer agreement.
- The agreement funds a marine deputy, a percentage of a lieutenant, and two seasonal positions;
- The agreement provides law enforcement services on the waterways of Marion County including the following:
  - o Boat inspections;
  - o Enforcement of boating laws and regulations;

- Educating school age students and adults on the importance of using safety devices; and
- o Search and rescue efforts.
- The agreement pays for 3,411 hours; and
- The Marine Board provides funding for boats and equipment.

- The Sheriff's Office is receiving a new boat this year;
- The Marine Board funds all boat purchases and then provides the equipment to the Sheriff's Office;
- Last year the Marine Board provided funding for two jet skis; and
- Commander Stutrud will get with the Marine Board to try and have other equipment updated:
  - O Aging buoys that are not staying upright.
