TITLE	Appointment to fill the Marion County Sheriff vacancy.
Background	Sheriff Joe Kast announced his retirement effective June 30, 2023. With this vacancy in the Sheriff's Office, the Marion County Board of Commissioners is responsible for selecting a replacement who will hold office until a new sheriff is chosen in the next general election. There was an open recruitment and public process to fill the vacancy. Interviews were held on June 7, 2023, and the board recommended Lieutenant Nick Hunter be appointed as Marion County Sheriff, effective June 30, 2023. Lieutenant Hunter has the background and experience with all aspects of the Sheriff's Office from enforcement, to the jail, and community corrections that made him standout. He has demonstrated his commitment to community engagement and has received broad support from local residents.
