WHEREAS, pursuant to ORS 471.166, each applicant for renewal of a liquor license must obtain from the Marion County Board of Commissioners a written recommendation; and

WHEREAS, pursuant to ORS 471.166, the Marion County Board of Commissioners must submit its recommendation (favorable or unfavorable) to the OLCC within 45 days after notice of pending renewal applications is given to the Board; and

WHEREAS, the Board having referred the application to the Sheriff of Marion County, Oregon, and having the report of said sheriff that the applicant establishment has not had any crimes committed upon its premises or other issues of public concern; NOW, THEREFORE,

IT IS HEREBY ORDERED that the Board recommends renewal of the OLCC liquor licenses for the establishments listed in Exhibit A, attached and incorporated herein.
