IT APPEARING to the Board that it has authority pursuant to ORS 565.210 to appoint members to the county fair board; that each member of the county fair board must furnish Marion County with a performance bond pursuant to ORS. 565.210 (3); and that Pamela Zielinski is a resident of Marion County and is qualified and willing to continue to serve on the Marion County Fair Board; now, therefore,

IT IS ORDERED that Pamela Zielinski be re-appointed as a member of the Marion County Fair Board with a term beginning on February 21, 2024 and ending on December 31, 2026 effective immediately to serve at the pleasure of the Marion County Board of Commissioners.

IT IS FURTHER ORDERED that Pamela Zielinski shall file with the Marion County Clerk, a good and sufficient bond in favor of Marion County, conditioned upon the faithful performance of the duties of the office of member of the Marion County Fair Board in the sum of \$50,000 for the 2024-2026 fiscal years.
