Requested Action: Appoint Victor Sanchez to the Marion County Fair Board, and presentation of recently appointed members Dana Castano and Greg Martin.

Issue, Description & Background: The Marion County Fair Board currently has one remaining board position open on the 7 member board. Victor Sanchez was recommended for appointment by the Marion County Fair Board after his interview February 7, 2024. The recommendation was then taken to a Management Update for approval February 27. The Marion County Fair Board recommends Victor Sanchez be appointed to the Marion County Fair Board filling the remaining term of a vacant position with a term ending date of December 31, 2025. Dana Castano and Greg Martin were appointed to the Marion County Fair Board on January 18th but were not able to attend. At the March 13, 2024 Board Session, both members will have an opportunity to be recognized.

Financial Impacts: A fair board bond insurance coverage fee of approximately \$200 per board member.

IT IS FURTHER ORDERED that Victor Sanchez shall file with the Marion County Clerk, a good and sufficient bond in favor of Marion County, conditioned upon the faithful performance of the duties of the office of member of the Marion County Fair Board in the sum of \$50,000 for the 2024-2026 fiscal years.
