### **PUBLIC COMMENT**

Paul Brakeman:

- Mr. Brakeman expressed the following:
  - He is the Mayor of the City of Scotts Mills;
  - He would like to bring attention to the deteriorating conditions of Scotts Mills Dam;
  - He has concerns about the dam's current condition;
  - Individuals enjoying the park often cross the creek onto private property:
    - Trespassing on private land is a frequent occurrence.
  - A piece of the dam broke off during the 2024 winter season;
  - Many community members have requested a status update for the dam;
  - He feels it would be safer if the dam was destroyed;
  - Removal of the dam may reduce trespassing on private property;
  - The concrete from the dam is breaking off into the pool making it more dangerous; and
  - He would like something to be done with the dam.

### **PUBLIC WORKS**

10. Consider approval of Amendment #1 to the Supplemental Project Agreement with the Oregon Department of Transportation (ODOT) to add \$1,757,583.03 for a new contract total of \$7,491,930.78 of which an estimated \$1,577,079.25 will utilize federal funds and an estimated \$180,503.78 will utilize county funds for safety improvements at the intersection of Ehlen Road NE and Butteville Road NE through March 1, 2034. –Ryan Crowther

#### ***Summary of presentation:***

- The project is located north of the City of Donald on Ehlen Road NE and Butteville Road NE;
- The project scope entails constructing a single lane rural roundabout where the two roads intersect;
- A design consultant has drafted three project options for the county to consider;
- Amendment #1 to the contract adds congressionally directed federal funding in the amount of \$1,577,079.25 to the project:
  - The additional funding provides more flexibility to ensure the roundabout can accommodate commercial vehicles and farm traffic.
- The project's preliminary schedule entails the following:
  - Preliminary engineering started in 2024;
  - Right-of-way acquisition in 2025; and
  - Construction will start in 2027.

#### ***Board discussion:***

- Outreach for the project includes:
  - A public meeting where multiple projects will be discussed;
  - Posting on the county's website;
  - Posting on social media;
  - A second public meeting will be held during the planning phase so that public comment and feedback can be incorporated into the plans; and
  - An open house with exhibits and timelines will be held.
- The project has been ongoing for a considerable length of time; and
- It will be better for the community once the project is completed.
