The 2023 Volunteer Annual Report offers a glimpse into the many contributions made by volunteers who have donated time to a county program, division, or department. While the report provides some quantifiable information, it can never demonstrate the immeasurable impact our volunteers make.

2023 bustled with activities in Marion County, and volunteers worked alongside staff through it all. 1,149 volunteers provided program support to Dog Services, 4-H and Extension Services, the County Fair, Victim Services, Justice Court, the Law Library, Environmental Services, Emergency Management, and the Sheriff's Office. We also hosted 40 students for their formal internship or practicum placements, helping them to meet their academic and professional goals.

174 community members served in an appointed position on behalf of the Marion County Board of Commissioners or the Sheriff, making the commitment to attend and actively participate on a board, committee, or commission. Many have served multiple terms and bring an unmatched perspective and historical knowledge to the table.

The year was filled with wonderful memories, and marked by many moments when volunteers showed us what it means to care and work on behalf of others. Regardless of the challenges, Marion County volunteers showed up ready to help and we are grateful for their service!

Spotlight: Volunteers make the Marion County Dog Shelter a place of hope, helping to care for the dogs at the shelter until they can be reunited with their owners or placed for adoption. Volunteers spent over 2,800 hours walking, playing, and helping to assess the dogs in our care and over 1,300 hours helping with shelter and clinic operations. Foster volunteers donated nearly 6,500 hours caring for dogs in their home, which is far less stressful than the shelter and can be critical for nursing, medically fragile, or highly stressed dogs. Volunteers also help with transportation, community outreach, and special licensing and adoption events.

Spotlight: Key Volunteers and Fair Superintendents support the Marion County Fair by providing project management for special events, projects, and open competitions. These dedicated volunteers spend several months planning and organizing, and then are on site during the fair to make sure everything runs smoothly. Superintendents put their organizational and people skills to work for their assigned area, ensuring that members of the public can participate and show their talents in creative arts, foods, floral & garden, photography, textiles, and more!

Spotlight: Each year three Marion County citizens join the Board of Commissioners to review and set the County's budget. Their work ensures an inclusive, transparent process that considers the County's estimated revenues and projected operating expenses. Budget Committee members provide important oversight and analysis, developing a yearly budget that ensures each of the 17 county departments will have the resources to deliver needed services to the citizens of Marion County. Collectively, the three citizen members have 49 years of experience with the County's budget cycle and approval process.

Spotlight: Public Health interns work on a variety of projects such as planning special activities and events, developing educational materials, and strengthening community partnerships. 2023 interns Kira F. and Ryan K. worked on the Breastfeeding Promotion Campaign for Women, Infants, and Children (WIC) program participants. After completing initial research, Kira and Ryan used the knowledge and skills gained as students at Oregon State University to develop and implement a campaign to combat social, cultural, logistical, and other barriers to breastfeeding. Lily T. and Madison M. focused on the Farm Direct Nutrition Program, which partners with local farmers to increase access to fresh, locally grown produce for WIC participants.

Spotlight: Volunteers step up to plant hundreds of trees at Packsaddle Park, which serves as one of the key put-in and take-out points for drift boaters, kayakers, and anglers who enjoy the North Santiam River. Temporarily closed after the 2020 Labor Day Fires, Packsaddle Park is one of six County parks slated for restoration and improvements. With the community's help, restoration of our Santiam Canyon parks will preserve our cultural heritage in the area and benefit residents and visitors for many years to come providing ample recreational opportunities, improved wildlife habitats, and improved watershed quality.

Spotlight: The cadet program is designed to further each volunteer's education and enhance their knowledge of law enforcement operations. Young people (ages 14 ½ - 21 years) complete the Sheriff's Office Cadet Academy and then work alongside sworn officers to learn about crime prevention, record keeping, radio communications, traffic and event control, and officer safety. Cadets are given the opportunity to challenge themselves as they prepare for a career in public safety, all while enhancing the work of the Sheriff's Office by assisting deputies on ride-alongs, providing crime scene security, helping at community events, and more.
