TITLE: Reappointment of Alton Hoover to the Marion County Parks Commission

Issue, Description & Background: Alton Hoover has expressed interest to continue serving on the Marion County Parks Commission as a citizen-at-large. There are currently three vacancies for the Commission. Alton Hoover has been serving on the Marion County Parks Commission since August 2019. The Marion County Board of Commissioners formed the MC Parks Commission on September 16, 1958. The commission membership consists of eleven citizen-at-large positions. The terms of the individual positions are four-year terms. The MC Parks Commission is a public body which, under its bylaws, makes recommendations to the Marion County Board of Commissioners. The County's policy and the MC Parks Commission by-laws require that the Marion County Board of Commissioners make the final appointments. All members serve at the pleasure of the Marion County Board of Commissioners.

Options for Consideration: 1. Reappoint Alton Hoover to the Parks Commission. 2. Do not reappoint Alton Hoover to the Parks Commission.

Recommendation: Public Works recommends that the Marion County Board of Commissioners appoint Alton Hoover to the Marion County Parks Commission for a term to begin on August 2, 2023 and to end June 30, 2027.
