Requested Action: Appoint Herschel Sangster to the Marion County Parks Commission Chair position.

Issue, Description & Background: Herschel Sangster has expressed interest to serve on the Marion County Parks Commission as Chair while continuing his service as a citizen-at-large. We will be seeking action at the November 29 Board Session. Marion County Parks Commission voted to elect Herschel at its September 21st public meeting. Herschel Sangster has served on the Marion County Parks Commission since March 2022. Commission membership consists of eleven citizen-at-large positions. The terms of the Chair and Vice-Chair are two years. The MC Parks Commission is a public body which, under its bylaws, makes recommendations to the Marion County Board of Commissioners. County policy and the MC Parks Commission by-laws require that the Marion County Board of Commissioners make the final appointments. All members serve at the pleasure of the Marion County Board of Commissioners.
