Issue, Description Background	The Public Works Department is in the process of constructing a new, countywide public safety-grade radio network to replace or supplement various smaller radio systems that curently exist within the county. The plan is to deploy the new radio system in Fall 2024. The new system will consist of a multi-channel 700/800 MHz interoperable radio network, an IP-based LAN for data backhauling, up to 14 radio broadcast sites, and dispatch terminal upgrades at various county, City of Salem and METCOM 911 facilities. The LAN must be operable before deployment of the new radio system begins. Some LAN components have an estimated acquisition lead time of 203 to 283 days, which means this equipment must be purchased now to satisfy the project schedule. This purchase will be made under Oregon Statewide Price Agreement SPA#1605,1607 and Omnia Partners / NCPA #01 97 held by CVE Technologies of Tigard, Oregon.

- 1. INSPECTIONS: County may inspect and test the Goods and related Services (collectively, Goods). County may reject non-conforming Goods and require Contractor to correct them without charge or deliver them at a reduced price, as negotiated. If Contractor does not cure any defects within a reasonable time, County may reject the Goods and cancel the PO in whole or in part. This paragraph does not affect or limit County's rights, including its rights under the Uniform Commercial Code, ORS chapter 72 (UCC).
- 2. DELIVERY: Deliveries will be F.O.B destination. Contractor shall pay all transportation and handling charges. Contractor is responsible and liable for loss or damage until final inspection and acceptance of the Goods. Contractor remains liable for latent defects, fraud, and warranties.
- 3. PAYMENT: County shall pay Contractor within 30 days from (i) the date the Goods are delivered and accepted or (ii) the date the invoice is received, whichever is later

- 5.
